AN ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ACCEPT A GRANT FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY'S, U.S. DEPARTMENT OF HOMELAND SECURITY, 2011 ASSISTANCE TO FIREFIGHTERS GRANT PROGRAM ON BEHALF OF THE ATLANTA FIRE RESCUE DEPARTMENT IN THE AMOUNT OF THREE HUNDRED AND NINETY-THREE THOUSAND, EIGHT-HUNDRED AND TWO DOLLARS, AND ZERO CENTS (\$393,802.00), FOR THE SUPPORT OF THE ATLANTA FIRE RESCUE DEPARTMENT'S HEALTH AND WELLNESS PROGRAM AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta Fire Rescue Department has designed a comprehensive Health and Wellness Program to address the contributing factors that lead to cardiac, respiratory, musculoskeletal injuries, and related risks; and

WHEREAS, the purpose of the Assistance for Firefighters Grant Program is to reduce the number of injuries to firefighters and minimize or eliminate factors that contribute to their deaths; and

WHEREAS, the Atlanta Fire Rescue Department applied and received preliminary grant award notification from the Federal Emergency Management Agency, U.S Department of Homeland Security, Assistance to Firefighters Grant Program of a grant award of \$393,802.00 to support the department's Health and Wellness Program; and

WHEREAS, the grant award includes a 20% matching fund requirement (\$78,760.00); and

WHEREAS, the Chief Financial Officer be and is hereby authorized to pay \$78,760 from the Fund 1001 (General Fund) 230101 (AFR Chief of Fire) 6110003(OPER transferred out to 2501) 1320000(Chief Executive) to the Fund 2501(Intergovernmental Fund) 230101 (AFR Chief of Fire) 1320000 (Chief Executive) 3912001 (OPER Transferred FRM Fund 1001)

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: that the Mayor or his designee is hereby authorized to accept a grant from the Federal Emergency Management Agency, U.S Department of Homeland Security, Assistance from Firefighters Grant Program in the amount of \$393,802.00 to support the Atlanta Fire Rescue Department's Health and Wellness Program.
