

AN ORDINANCE AMENDING ATLANTA CODE OF ORDINANCES SECTION 110-3 TO MODIFY RENTAL FEES FOR THE CITY-OWNED SHOWMOBILE STAGE, SO THAT THE FEES CURRENTLY CHARGED COVER AN EIGHT-HOUR RENTAL PERIOD RATHER THAN A ONE HOUR RENTAL PERIOD; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") Code of Ordinances, Section 110-3 ("Fee Schedule") establishes a fee structure for individuals and groups wishing to utilize City equipment and amenities, and to participate in City programs, offered by the Department of Parks, Recreation and Cultural Affairs; and

WHEREAS, one of the pieces of equipment available for rent is a showmobile stage ("Showmobile"); and

WHEREAS, the current rental rate for the Showmobile ranges from \$350 per hour for resident tax-exempt companies to \$800 per hour for non-resident for-profit companies, with a minimum four-hour rental required; and

WHEREAS, the City wishes to amend the Showmobile fees by keeping the dollar amounts the same, but changing the "per hour" time period to a "per eight-hour" time period.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

Atlanta Code of Ordinances Section 110-3 entitled "Fee Schedule", Section (a)(2) entitled "Equipment Rental", subsection "a.", which currently reads:

- "a. Showmobiles, per hour, four hours minimum:
 - Tax exempt resident organizations\$350.00
 - All other resident organizations\$450.00
 - Tax exempt nonresident organizations\$600.00
 - All other nonresident organizations\$800.00"

shall be amended by deleting "per hour, four hours minimum", and replacing it with "per eight-hour period".



As amended, subsection (a)(2)a. shall read:

- “a. Showmobiles, per eight-hour period:
Tax exempt resident organizations\$350.00
All other resident organizations\$450.00
Tax exempt nonresident organizations\$600.00
All other nonresident organizations\$800.00”
