**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO VARIOUS CONTRACTUAL AGREEMENTS ADMINISTERED BY THE DEPARTMENT OF FINANCE AND THE DEPARTMENT OF WATERSHED MANAGEMENT FOR THE ENGLISH AVENUE PROJECT IN THE AMOUNT OF ONE HUNDRED THOUSAND DOLLARS AND NO CENTS (\$100,000.00) AND THE CARE AND CONSERVE PROJECT IN THE AMOUNT OF THREE HUNDRED THOUSAND DOLLARS AND NO CENTS (\$300,000.00), AS IDENTIFIED UNDER THE 2012 ANNUAL ACTION PLAN FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT; AND FOR OTHER PURPOSES**

**WHEREAS**, pursuant to Ordinance 11-O-1431, adopted by the City Council of the City of Atlanta, Georgia (the "City") on November 7, 2011 and approved per City Charter Section 2-403 on November 16, 2011, the City approved funding in the 2012 Annual Action Plan for the Community Development Block Grant ("CDBG") program for the English Avenue Campus project in the amount of One Hundred Thousand Dollars and No Cents (\$100,000.00) and the Care and Conserve project in the amount of Three Hundred Thousand Dollars and No Cents (\$300,000.00) to support the preservation of infrastructure in affordable housing and to revitalize neighborhoods; and

**WHEREAS**, the City has obtained release of funds from the U.S. Department of Housing and Urban Development ("HUD") for these projects based on the filing of environmental clearances.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES AS FOLLOWS**, that the Mayor or his designee be and is authorized hereby to enter into contractual agreements for the following CDBG projects assigned to the Department of Finance and the Department of Watershed Management shown on Attachment 1.

**BE IT FURTHER RESOLVED**, that the City Attorney be and is hereby directed to prepare the appropriate contractual agreements for execution by the Mayor or his designee.

**BE IT FURTHER RESOLVED**, that said contractual agreements shall not become binding on the City and the City shall incur no liability upon the same until such contracts are approved by the City Attorney as to form, executed by the Mayor or his designee, attested to by the Municipal Clerk, and delivered to the contracting parties.

**BE IT FINALLY RESOLVED**, that all resolutions and parts of resolutions in conflict with this resolution are hereby waived to the extent of the conflict.
