**A RESOLUTION AUTHORIZING THE SETTLEMENT OF ALL CLAIMS AGAINST THE CITY OF ATLANTA IN THE CASE OF JALLALO YUSSUF V. CITY OF ATLANTA, ET AL., CIVIL ACTION FILE NUMBER 1:11-CV-1667-AT-JFK, UNITED STATES DISTRICT COURT, NORTHERN DISTRICT OF GEORGIA, ATLANTA DIVISION, IN THE AMOUNT OF \$15,000.00; AUTHORIZING PAYMENT OF \$15,000.00 TO BE CHARGED TO AND PAID FROM FUND 1001 (GENERAL FUND), CENTER NUMBER 200101 (NON-DEPARTMENTAL), ACCOUNT 5212005 (LITIGATION EXPENSES) and FUNCTIONAL ACTIVITY NUMBER 151200 (ACCOUNTING); AUTHORIZING THE CHIEF FINANCIAL OFFICER TO DISTRIBUTE THE SETTLEMENT AMOUNT; AND FOR OTHER PURPOSES.**

**WHEREAS, *Jallalo Yussuf v. City of Atlanta, et al.*, is a case in which the Plaintiff, Jallalo Yussuf, sought remedy and redress for alleged deprivation of his Fourth Amendment rights after the officer used alleged excessive force during his arrest; and**

**WHEREAS, Plaintiff has agreed to accept \$15,000.00 in full settlement of all claims against the police officer, inclusive of interest and attorney's fees; and**

**WHEREAS, the City Attorney has done extensive review of the facts and the law and has determined that the City's potential financial exposure in defending Plaintiff's claims is in excess of the settlement amount; and**

**WHEREAS, the City Attorney considered it to be in the best interest of the City to pay the amount of \$15,000.00 to settle all claims against the City of Atlanta's police officer.**

**THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA hereby resolves as follows:**

**SECTION 1. The City Attorney is hereby authorized to settle and execute all documents in the case of *Jallalo Yussuf v. City of Atlanta, et al.* in the amount of Fifteen-Thousand Dollars and Zero Cents (\$15,000.00).**



**SECTION 2.** Said payment is to be charged, paid and issued as follows:

The Chief Financial Officer is authorized to make payment from **Fund 1001 (General Fund), Center Number 200101 (Non-Departmental), (Account 5212005 (Litigation Expenses) and Functional Activity Number 1512000 (Accounting)). Payment shall be in the form of a check in the amount of \$15,000.00 payable to Joyce Thrasher Kaiser & Liss, LLC.**

Such payment shall be in full consideration of the dismissal of all claims against the City of Atlanta and its current and former police officers.
