**A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY OF ATLANTA, TO ENTER INTO AN APPROPRIATE CONTRACTUAL AGREEMENT WITH SCOTT AND SONS HOLDINGS, LLC FOR FC-5401, SPINKS COLLINS PLAYGROUND IMPROVEMENTS, ON BEHALF OF THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS IN AN AMOUNT NOT TO EXCEED ONE HUNDRED SIXTY FIVE THOUSAND FOUR HUNDRED ELEVEN DOLLARS AND THIRTY THREE CENTS (\$165,411.33); ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM: 2201 (COMMUNITY DEVELOPMENT BLO) 140106 (PRC PARKS DESIGN) 5212001 (CONSULTUNG/PROFESSIONAL) 6220000 (PARK AREAS) 110470 (SPINKS COLLINS PK 2009 CD) 3270 (SPINKS COLLINS) 31764 (CDBG 2008) - \$138,311.00 AND 3501 (PARK IMPROVEMENT FUND) 140106 (PRC PARKS DESIGN) 5222003 (REPAIR & MAINTENANCE- OTHER) 6220000 (PARK AREAS)- \$27,100.33; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta (“City”) owns Spinks-Collins Park located at 2001 Collins Drive, N.W., 30318 (the “Park”) in Council District 9; and

**WHEREAS**, City did issue Invitations to Bid for qualified firms for FC-5401, Spinks-Collins Playground Improvements; and

**WHEREAS**, this project will consist of a new playground area with installation of new equipment, a concrete sidewalk, mulch trail, decorative bioswale for proper drainage, and landscaping; and

**WHEREAS**, the performance of this agreement shall be completed within One Hundred Eighty (180) days, with the option to extend on a month-to-month basis as needed not to exceed Eight (8) additional months at the sole discretion of the City; and

**WHEREAS**, Scott and Sons Holdings, LLC (“Scott and Sons”) was determined to be the most responsive and responsible bidder; and

**WHEREAS**, the Commissioner of the Department of Parks, Recreation and Cultural Affairs and the Chief Procurement Officer recommend that the contract for FC-5401, Spinks-Collins Playground Improvements, be awarded to Scott and Sons, in an amount not to exceed One Hundred Sixty Five Thousand Four Hundred Eleven Dollars and Thirty Three Cents (\$165,411.33).

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES**, that the Mayor, or his designee, be and is hereby authorized to enter into an appropriate contractual agreement with Scott and Sons, for FC-5401, Spinks-Collins Playground Improvements, on behalf of the Department of Parks, Recreation and Cultural Affairs, in an amount not to exceed One Hundred Sixty Five Thousand Four Hundred Eleven Dollars and Thirty Three Cents (\$165,411.33).



**BE IT FURTHER RESOLVED**, that performance of this Agreement shall be completed within One Hundred Eighty (180) days, with the option to extend on a month-to-month basis as needed not to exceed Eight (8) additional months at the sole discretion of the City.

**BE IT FURTHER RESOLVED**, that the Chief Procurement Officer be and is hereby directed to prepare the appropriate contractual agreement for execution by the Mayor.

**BE IT FURTHER RESOLVED**, that all contracted work shall be charged to and paid from: 2201 (Community Development BLO) 140106 (PRC Parks Design) 5212001 (Consulting/Professional) 6220000 (Park Areas) 110470 (Spinks Collins PK 2009 CD) 3270 (Spinks Collins) 31764 (CDBG 2008)- \$138,311.00 and 3501 (Park Improvement Fund) 140106 (PRC Parks Design) 5222003 (Repair & Maintenance-Other) 6220000 (Park Areas)- \$27,100.33.

**BE IT FINALLY RESOLVED**, that this agreement shall not become binding upon the City, and the City shall incur no liability upon the same until it has been approved by the City Attorney as to form, executed by the Mayor, attested to by the Municipal Clerk, and delivered to Scott and Sons.
