

**A RESOLUTION BY THE ATLANTA CITY COUNCIL  
AS AMENDED**

**A RESOLUTION APPROVING THE APPOINTMENT OF CANDIDATE  
TANGELA WILLIAMS TO THE POSITION OF DIRECTOR OF COUNCIL  
STAFF; AND FOR OTHER PURPOSES.**

**WHEREAS**, the position of Director of Council Staff is now vacant; and

**WHEREAS**, the Committee on Council caused the creation of a Council Sub-committee/  
Task Force for the purpose of accepting and assessing applications for the vacant  
Director of Council Staff position, and for narrowing the pool of acceptable candidates;  
and

**WHEREAS**, in excess of three hundred (300) applications were received for the vacant  
position and the number of eligible and acceptable candidates was ultimately reduced to  
three individuals; and

**WHEREAS**, a Communication dated May 21, 2012 and identified as No. 12-C-0773  
naming three finalists to serve as Council Staff Director was introduced and held on that  
date by the Committee on Council; and

**WHEREAS**, the communication identified Ms. Claire McLeveighn, Mr. Larry Stokes,  
and Ms. Tangela Williams, as the three finalists for the position of Director of Council  
Staff; and

**WHEREAS**, during an Executive Session of a Special Call Meeting of the Atlanta City  
Council held on Monday morning, June 4, 2012, the members of the Council present had  
the opportunity to meet and to interview each of the three finalists; and

**WHEREAS**, following the Atlanta City Council's return from Executive Session to the  
Special Call Meeting, said meeting was adjourned; subsequently the Council's Regular  
Meeting convened and therein, Council Members cast handwritten ballots to select the  
Director of Council Staff; and

**WHEREAS**, the Municipal Clerk properly tabulated such ballots.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF  
ATLANTA, GEORGIA** that the Council has conducted a vote at a Regular Meeting of  
the City Council held on June 4, 2012.

**BE IT FURTHER RESOLVED**, that as a result of said vote, Tangela Williams has  
been selected to be offered the position to serve as the Director of Council Staff, with  
copies of all ballots and the resulting tabulation sheet, being appended hereto as Exhibit  
"A".
