


**AN ORDINANCE TO CORRECT ORDINANCE 12-O-0088 ADOPTED BY THE CITY COUNCIL ON FEBRUARY 6, 2012 AND APPROVED PER CITY CHARTER SECTION 2-403 ON FEBRUARY 15, 2012 BY DELETING THE INCORRECT GRANT AMOUNT FOR THE FUND DEPARTMENT ORGANIZATION AND ACCOUNT NUMBER AND INSERTING IN LIEU THEREOF THE CORRECT GRANT AMOUNT FOR THE DEPARTMENT ORGANIZATION AND ACCOUNT NUMBER; APPROVING AND ACCEPTING AHA CATALYST GRANT FUNDS; AND ACCEPTING AN INCREASE IN GRANT FUNDS; AMENDING THE 2012 ATLANTA WORKFORCE DEVELOPMENT AGENCY AHA CATALYST PROGRAM BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF EIGHT HUNDRED THIRTY ONE THOUSAND DOLLARS (\$831,000.00) FOR THREE CONTACT TERMS BEGINNING JULY 1, 2010, JULY 1, 2011, AND JULY 1, 2012; AND FOR OTHER PURPOSES.**

**WHEREAS**, the purpose of the Atlanta Workforce Development Agency (“AWDA”) is to serve the citizens of the City of Atlanta (“the City”) by providing employment, job training, career development, job readiness, job placement and other supportive services; and

**WHEREAS**, the AHA requires all non-disabled adults between the ages of 18 and 61 receiving housing assistance from AHA to be engaged in at least thirty (30) hours a week of employment, education and/or job training pursuant to the CATALYST Work Requirement (“CATALYST Requirement”); and

**WHEREAS**, the City is willing to support AHA-assisted families who are not currently in compliance with the CATALYST Requirement; and

**WHEREAS**, the City authorized a previous resolution to accept up to \$1,250,000.00 in grants under the Catalyst program in 10-R-1577; and

**WHEREAS**, the City Council has approved Ordinance 12-O-0088 to receive an increase of Two Hundred Twelve Thousand (\$212,000.00) in grant funds for a total amount of \$1,462,000.00 over a five year period; and

**WHEREAS**, the City must anticipate and appropriate the funds by Ordinance; and

**WHEREAS**, Ordinance 12-O-008 listed an incorrect grant amount in the Fund Department Organization and Accounting Number (“FDOA”); and

**WHEREAS**, it is the desire of Atlanta Workforce Development Agency (“AWDA”) that Ordinance 12-O-0088 display the correct grant amount in the FDOA.



**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:**

**Section 1:** That the 2012 AHA Catalyst Budget be increased by Two Hundred and Twelve Thousand Dollars (\$212,000.00) for a total of \$1,462,000.00 over five years per the adjustment found in Exhibit A attached hereto.

**Section 2:** That the Mayor is authorized to execute any documents necessary to facilitate any increase in grant dollars for the Catalyst grant.

**Section 3:** That Ordinance 12-O-0088 be corrected by deleting the incorrect grant amount in the accounting string and replacing it with the following grant amount wherever the incorrect amount appears in the legislation:
