WHEREAS, the Department of Police ("Department") has been an active participant in the High Intensity Drug Trafficking Area (HIDTA) task force for over ten years; and

WHEREAS, the White House Office of National Drug Control Policy ("ONDCP") grants funding to local task forces responsible for disrupting and dismantling violent drug trafficking organizations; and

WHEREAS, the ONDCP has awarded the City a grant # GIOGA0003A in the amount of five million, six hundred twenty five thousand, seven hundred sixty-eight dollars (\$5,625,768) to continue funding BIDTA task force initiatives; and

WHEREAS, the Board of Directors has awarded funding for to the City of Atlanta for \$93,401 for the first year of funding and Administration funding will continue for the duration of the grant to help defray Administration Cost for Atlanta Police Department (ADP) and Grant Service Division and for the creation of a Position (Contract Coordinator) with benefits and;

WHEREAS, the Atlanta Police Department CAPD) and Grant Service Division wishes to accept the grant ill the amount of\$93,401 for the first year of funding and will continue to accept funding for future years for both Administration cost for Atlanta Police Department (APD) and Grant Service Division. At the end of each fiscal year partial cost incurred for The Atlanta Police Department (APD) and Grant Services Administration cost will be transferred to this cost center Fund 2501 242110795112001250151986 101-103 5112001.
