

**A SUBSTITUTE RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO ENTER INTO COOPERATIVE PURCHASE AGREEMENTS WITH LANDSCAPE STRUCTURES, INC., AND PLAYWORLD SYSTEMS, INC. UTILIZING THE HOUSTON-GALVESTON AREA COUNCIL PURCHASING PROGRAM CONTRACT NUMBER PR11-10, FOR COA-5993-AT BEGINNING IN FY 2013, PURSUANT TO SECTION 2-1601 OF THE PROCUREMENT AND REAL ESTATE CODE OF THE CITY OF ATLANTA, FOR THE PURPOSE OF PURCHASING PLAYGROUND EQUIPMENT AT VARIOUS CITY OF ATLANTA PARKS, IN AN AMOUNT NOT TO EXCEED FIVE HUNDRED THOUSAND DOLLARS AND NO CENTS (\$500,000.00) PER YEAR, FOR A TERM OF TWO YEARS WITH A ONE YEAR RENEWAL OPTION AT THE SOLE DISCRETION OF THE CITY; WITH ALL CONTRACTED WORK BEING CHARGED TO AND PAID FROM THE ACCOUNTS LISTED HEREIN; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta (“City”) owns, operates and manages over 350 parks and beauty spots throughout the city of Atlanta (collectively the “Parks”); and

**WHEREAS**, a number of Parks are in need of upgraded playground equipment and other site amenities; and

**WHEREAS**, pursuant to Article X, Division 15 Intergovernmental Relations of the City of Atlanta Code of Ordinances, the Chief Procurement Officer may procure supplies, services or construction items through contracts established by a public procurement unit outside the City; and

**WHEREAS**, the Commissioner of the Department of Parks, Recreation and Cultural Affairs (“DPRCA”) and the Chief Procurement Officer have identified contracts with Landscape Structures, Inc., and Playworld Systems, Inc., utilizing the Houston-Galveston Area Council Purchasing Program (“HGAC”) contract PR11-10, for the cooperative purchase of playground equipment; and

**WHEREAS**, HGAC is a nonprofit regional organization consisting of local governments that reduce the costs of goods and services for participating agencies by executing competitively priced contracts for goods and services commonly used by local governments; and

**WHEREAS**, Georgia local governments that have purchased goods and services through HGAC include: Athens-Clarke County, Chatham County, Bibb County, and the Cities of East Point, Canton, Roswell, and Smyrna; and

**WHEREAS**, the Commissioner of DPRCA and the Chief Procurement Officer recommend utilizing the HGAC contracts with Landscape Structures, Inc., and Playworld Systems, Inc., for the purpose of purchasing Park equipment for an initial term of two (2) years with one-one (1)



year renewal option at the City's sole discretion in an amount not to exceed Five Hundred Thousand Dollars and No Cents (\$500,000.00) per year.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA,** that the Mayor or his designee, on behalf of the City, is authorized to enter into cooperative purchase agreements with Landscape Structures, Inc., and Playworld Systems, Inc., utilizing HGAC contract PR11-10, for COA-5993-AT, beginning in FY 2013, for the purpose of purchasing playground equipment in an amount not to exceed Five Hundred Thousand Dollars and No Cents (\$500,000.00) per year.

**BE IT FURTHER RESOLVED,** that the agreement shall be for an initial term of two (2) years with one-one (1) year renewal option at the City's sole discretion.
