A RESOLUTION AUTHORIZING THE CONTINUATION OF RE-EMPLOYMENT OF  
REGINALD GRANT AS A LEGISLATIVE RESEARCH AND POLICY ANALYST FOR  
THE ATLANTA CITY COUNCIL, PURSUANT TO SECTION 3-505 (C) OF THE  
CHARTER OF THE CITY OF ATLANTA; FOR A PERIOD OF NOT MORE THAN 120  
DAYS; AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta City Council is in need of research and policy analysis staffing assistance for the Finance/Executive Committee and transportation Committee; and

WHEREAS, the Atlanta City Council adopted resolution, 12-R-0356 ("Resolution"), which was adopted on March 12, 2012 by the Atlanta City Council and approved on March 28, 2012 per Section 2-403 of the City Charter which authorized the re-employment of a retired employee, Reginald Grant; and

WHEREAS, the Resolution employed Mr. Grant through June 2012; and

WHEREAS, Section 3-505(c) of the City Charter authorizes that the City may re-employ a retiree which shall not exceed 520 business days, for the purpose of availing the City of particularized skills possessed by said retiree; and

WHEREAS, the Atlanta City Council desires to retain the services of Mr. Grant for an additional 120 days; and

WHEREAS, the Atlanta City Council and Mr. Grant have mutually agreed to his reemployment as a Research and Policy Analyst.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Atlanta City Council is authorized to re-employ Reginald Grant as a Research and Policy Analyst in an extra-help capacity without benefits, for a period not to exceed 120 days at a rate of Forty Two Dollars and Fifteen Cents (\$42.15) per hour, as authorized pursuant to Section 3-505(c) of the City Charter.
