A SUBSTITUTE ORDINANCE AMENDING THE 2010 INTERGOVERNMENTAL FUND BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS NEIGHBORHOOD STABILIZATION PROGRAM, PROGRAM INCOME IN THE AMOUNT OF ONE MILLION TWO HUNDRED FIFTY-TWO THOUSAND FIVE HUNDRED SEVENTY-FIVE DOLLARS AND NO CENTS (\$1,252,575.00) FOR THE PURPOSE OF FUNDING THE NEIGHBORHOOD STABILIZATION PROGRAM; AND FOR OTHER PURPOSES

WHEREAS, under Title III of Division B of the Housing and Economic Recovery Act, 2008 \$12.3 million has been appropriated to the City of Atlanta (“City”) to fund the CDBG Neighborhood Stabilization Program (“HUD NSP”) for emergency assistance for redevelopment of abandoned and foreclosed homes and residential properties; and

WHEREAS, the Georgia Department of Community Affairs (“DCA”) also has a CDBG Neighborhood Stabilization Program (“DCA NSP”) for emergency assistance for redevelopment of abandoned and foreclosed homes and residential properties; and

WHEREAS, the DCA NSP and HUD NSP each generate program income; and

WHEREAS, the DCA NSP program income is recorded in accordance with Ordinance 11-O-1433 adopted by the Atlanta City Council November 7, 2011 and approved per City Charter Section 2-403 on November 16, 2011 and HUD NSP program income is recorded in accordance with Ordinance 11-O-1268 adopted by Atlanta City Council on September 19, 2011 and approved per City Charter Section 2-403 on September 28, 2011; and


WHEREAS, the City desires to use the program income to fund additional HUD NSP projects; and

WHEREAS, it is necessary to transfer anticipations and appropriations from 2501.250305.3311104.7310000.211164.92020 to 2501.250305.3311104.7310000.210568.92020 in the amount of Fifty Thousand Dollars and No Cents (\$50,000.00) of Program Income for Environs Residential Design & Construction for HUD NSP project completion; and

WHEREAS, it is necessary to transfer anticipations and appropriations from 2501.250305.3311104.7310000.211164.92020 to 2201.250305.3311104.7310000.210408.92005 in the amount of Forty Thousand Dollars and No Cents (\$40,000.00) of Program Income for Pohl Real Estate, LLC., for HUD NSP project completion; and

WHEREAS, it is necessary to transfer anticipations and appropriations from 2501.250305.3311104.7310000.211164.92020 to 2501.250305.3311104.7310000.210568.92020 in the amount of One Hundred Seventy-Five Thousand Two Hundred and Seventy-Nine Dollars and No Cents (\$175,279.00) of Program Income for Fulton County/City of Atlanta Land Bank Authority, for HUD NSP project completion; and

WHEREAS, it is necessary to transfer anticipations and appropriations from 2201.250305.3311104.7310000.211163.92005 to 2201.250305.3311104.7310000.210408.92005



in the amount of Nine Hundred, Eighty-Seven Thousand, Two Hundred Ninety-Six Dollars and No Cents (\$987,296.00) of Program Income for Fulton County/City of Atlanta Land Bank Authority Inc., for HUD NSP project completion.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the 2010 Intergovernmental Fund Budget be and are hereby amended as follows:


