AN ORDINANCE AMENDING THE 2012 (VIA ADULT JOB TRAINING FUND) BUDGET, ATLANTA WORKFORCE DEVELOPMENT AGENCY, PASSED IN ORDINANCE 11-0-1769, ADOPTED BY THE ATLANTA CITY COUNCIL ON DECEMBER 5, 2011 AND APPROVED AS PER CITY CHARTER SECTION 2-403 ON DECEMBER 14, 2011, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TWENTY-TWO THOUSAND SEVEN DOLLARS (\$22,007.00) TO REFLECT AN INCREASE IN THE GRANT AMOUNT TO \$1,671,697.00 IN THE WORKFORCE INVESTMENT ACT ADULT JOB TRAINING FUND FROM THE GEORGIA DEPARTMENT OF LABOR, TO PROVIDE JOB TRAINING AND OTHER SKILLS TO LOCAL ADULT WORKERS; AND FOR OTHER PURPOSES.




AN ORDINANCE AMENDING THE 2012 (WIA ADULT JOB TRAINING FUND) BUDGET, ATLANTA WORKFORCE DEVELOPMENT AGENCY, PASSED IN ORDINANCE 11-O-1769, ADOPTED BY THE ATLANTA CITY COUNCIL ON DECEMBER 5, 2011 AND APPROVED AS PER CITY CHARTER SECTION 2-403 ON DECEMBER 14, 2011, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TWENTY-TWO THOUSAND SEVEN DOLLARS (\$22,007.00) TO REFLECT AN INCREASE IN THE GRANT AMOUNT TO \$1,671,697.00 IN THE WORKFORCE INVESTMENT ACT ADULT JOB TRAINING FUND FROM THE GEORGIA DEPARTMENT OF LABOR, TO PROVIDE JOB TRAINING AND OTHER SKILLS TO LOCAL ADULT WORKERS; AND FOR OTHER PURPOSES.

WHEREAS, the purpose of the Workforce Investment Act (“WIA”) is to provide workforce investment activities through statewide and local workforce systems in order to increase employment, retention, the earnings of citizens, and the attainment of occupational skills for participants, thereby improving the quality of the workforce; and

WHEREAS, the Georgia Department of Labor (“GDOL”) has awarded the City of Atlanta (“City”), through the Atlanta Workforce Development Agency (“AWDA”), a grant in the amount of one million six hundred forty-nine thousand six hundred ninety dollars (\$1,649,690.00), to provide training funds for adult workers who need to upgrade or acquire skills to obtain full-time employment at livable wages; and

WHEREAS, under an Ordinance that was adopted by the Atlanta City Council on December 5, 2011 and approved as per City Charter Section 2-403 on December 14, 2011, AWDA originally recommended increasing receipts in the 2012 (WIA Adult Job Training Fund) budget by one million six hundred forty-nine thousand six hundred ninety dollars (\$1,649,690.00) in the WIA Adult Job Training Fund.

WHEREAS, GDOL has voluntarily awarded an additional grant in the amount of twenty-two thousand seven dollars (\$22,007.00) to AWDA for placement in the WIA Adult Job Training Fund.

WHEREAS, AWDA recommends increasing receipts in the 2012 (WIA Adult Job Training Fund) budget by twenty-two thousand seven dollars (\$22,007.00), resulting in the WIA Adult Job Training Fund being comprised of one million six hundred seventy-one thousand six hundred ninety-seven dollars (\$1,671,697.00).

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the 2012 (WIA Adult Job Training Fund) budget be increased by \$22,007.00 for a total of \$1,671,697.00 per the adjustment found in Exhibit A attached hereto.



Section 2: That the 2012 (WIA Adult Job Training Fund) budget is hereby amended as follows:
