**AN ORDINANCE AMENDING THE 2012 (WIA DISLOCATED WORKER JOB TRAINING FUND) BUDGET, ATLANTA WORKFORCE DEVELOPMENT AGENCY, PASSED IN ORDINANCE 11-O-1770, ADOPTED AS AMENDED BY THE COUNCIL ON DECEMBER 5, 2011 AND APPROVED AS PER CITY CHARTER SECTION 2-403 ON DECEMBER 14, 2011, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF ELEVEN THOUSAND FOUR HUNDRED EIGHTY-TWO DOLLARS (\$11,482.00) TO REFLECT AN INCREASE IN THE GRANT AMOUNT TO \$872,183.00 IN THE WORKFORCE INVESTMENT ACT DISLOCATED WORKER JOB TRAINING FUND FROM THE GEORGIA DEPARTMENT OF LABOR, TO PROVIDE JOB TRAINING AND OTHER SKILLS TO LOCAL DISLOCATED WORKERS; AND FOR OTHER PURPOSES.**

**WHEREAS**, the purpose of the Workforce Investment Act (“WIA”) is to provide workforce investment activities through statewide and local workforce systems in order to increase employment, retention, the earnings of citizens, and the attainment of occupations skill for participants, thereby improving the quality of the workforce; and

**WHEREAS**, the Georgia Department of Labor (“GDOL”) has awarded the City of Atlanta (“City”), through the Atlanta Workforce Development Agency (“AWDA”), a grant in the amount of eight hundred sixty thousand seven hundred one dollars (\$860,701.00), to provide training funds for dislocated workers who need to upgrade or acquire skills to obtain full-time employment at livable wages; and

**WHEREAS**, under an Ordinance that was adopted as amended by the Council on December 5, 2011 and approved as per City Charter Section 2-403 on December 14, 2011, AWDA originally recommended increasing receipts in the 2012 (WIA Dislocated Worker Job Training Fund) budget by eight hundred sixty thousand seven hundred one dollars (\$860,701.00) in the WIA Dislocated Worker Job Training Fund.

**WHEREAS**, GDOL has voluntarily awarded an additional grant in the amount of eleven thousand four hundred eighty-two dollars (\$11,482.00) to AWDA for placement in the WIA Dislocated Worker Job Training Fund.

**WHEREAS**, AWDA recommends increasing receipts in the 2012 (WIA Dislocated Worker Job Training Fund) budget by eleven thousand four hundred eighty-two dollars (\$11,482.00), resulting in the WIA Dislocated Worker Job Training Fund being comprised of eight hundred seventy-two thousand one hundred eighty-three dollars (\$872,183.00).

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:**

**Section 1:** That the 2012 (WIA Dislocated Worker Job Training Fund) budget be increased by \$11,482.00 for a total of \$872,183.00 per the adjustment found in Exhibit A attached hereto.



**Section 2:** That the 2012 (WIA Dislocated Worker Job Training Fund) budget is hereby amended as follows:
