ALL SERVICES SHALL BE CHARGED TO AND PAID FROM PTAE0: 18102843 (CENTRAL ADMINISTRATION) 200 (TASK) 550291249 (DOA R N E 9999) 5212001 (CONSULTING/PROFESSIONAL SERV) AND FDOA: 5502 (AIRPORT RENEWAL AND EXTENSION FUND) 180201 (DOA AVIATION CAPITAL PLANNING & DEVELOPMENT) 5212001 (CONSULTING/PROFESSIONAL SERV) 7563000 (AIRPORT) 102843 (CENTRAL ADMINISTRATION) 91249 (DOA R N E 9999); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (the "City") as owner and operator of Hartsfield-Jackson Atlanta International Airport ("Airport") entered into Contract FC-6006007929-A ("Contract"); Architectural and Engineering Design Services with Hartsfield Support Services Team ("HSST") for the provision of as-needed design services on a Task Order basis, pursuant to Resolution 07-R-1461, adopted by the City Council on July 16, 2007 and approved by the Mayor on July 19, 2007; and

WHEREAS, the City's Department of Aviation (DOA) desires to complete the Concourse T Gate Layout project (the "Project"), involving the addition of gates, loading bridges, fuel pits, revised aircraft parking, relocation of ticket counters, reconfiguration of Concourse space and related services; and

WHEREAS, the Aviation General Manager has determined that it is desirable and in the City's best interest to increase the compensation limit under the Contract in the amount of \$2,500,000.00 and to assign the Project to HSST via a Task Order.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA GEORGIA, that the compensation limit under the Contract is increased by an additional amount of \$2,500,000.00 in order to fund HSST's services for the Project.

BE IT FURTHER RESOLVED, that the Aviation General Manager or his designee is each authorized to issue to HSST Task Order(s) under the Contract for the Project up to the collective amount of all monies legislatively authorized under it, pursuant to Code section 2-1111.



BE IT FURTHER RESOLVED, that HSST is expected to complete all services for the Project within 913 calendar days from the date such services begins and, to the extent the services issued by said Task Order(s) may extend beyond the Contract term, said Contract is extended for such Task Order(s) only.

BE IT FURTHER RESOLVED, that all contracted work shall be charged to and paid from PTAE0: 18102843 (Central Administration) 200 (Task) 550291249 (DOA R N E 9999) 5212001 (Consulting/Professional Serv) and FDOA: 5502 (Airport Renewal & Extension Fund) 180201 (DOA Aviation Capital Planning & Development) 5212001 (Consulting/Professional Serv) 7563000 (Airport) 102843 (Central Administration) 91249 (DOA R N E 9999).

BE IT FINALLY RESOLVED, that no Task Order will become binding on the City and the City will incur no liability under it until it has been executed by the Aviation General Manager or his designee and delivered to HSST.
