

**AN ORDINANCE**

**AN ORDINANCE AUTHORIZING THE MAYOR TO ACCEPT AND SIGN A SUPPLEMENTAL GRANT AGREEMENT WITH THE UNITED STATES ENVIRONMENTAL PROTECTION AGENCY IN THE AMOUNT OF THREE HUNDRED AND FIFTY THOUSAND DOLLARS AND NO CENTS (\$350,000.00) FOR THE BROWNFIELD REVOLVING LOAN FUND PROGRAM; AMENDING THE 2012 (INTERGOVERNMENTAL GRANT FUND) BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF THREE HUNDRED AND FIFTY THOUSAND DOLLARS AND NO CENTS (\$350,000.00); AND FOR OTHER PURPOSES.**

**WHEREAS**, pursuant to Ordinance 09-O-1415, the City of Atlanta accepted a 2009 Brownfield Revolving Loan Fund grant in the amount of \$1,000,000.00 from the United States Environmental Protection Agency (“EPA”).

**WHEREAS**, since the signing of the grant agreement with EPA, the Office of Planning and Invest Atlanta have worked in partnership to disburse sixty-five percent (65%) of the brownfield grant funds, thereby automatically qualifying the City to receive supplemental brownfield grant funds from EPA; and

**WHEREAS**, EPA, Region 4, has notified the City that it will receive an additional \$350,000.00 in brownfield grant funds for its current Brownfield Revolving Loan Fund program; and

**WHEREAS**, this supplemental brownfield grant will require a twenty percent (20%) match (\$70,000.00).

**NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS:**

**Section 1.** The Mayor is authorized to sign a supplemental brownfield grant agreement with the United States Environmental Protection Agency an amount not to exceed Three Hundred Fifty Thousand Dollars and No Cents (\$350,000.00) for the City’s Brownfield Revolving Loan Fund program.

**Section 2.** The 2012 Intergovernmental Grant Fund budget is hereby amended as follows:
