A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO ENTER INTO A COOPERATIVE PURCHASE AGREEMENT WITH THE PUBLIC GROUP UTILIZING THE STATE OF GEORGIA'S CONTRACT NUMBER 40300-222-0000000031D, FOR FC-5566, ONLINE AUCTIONEER SERVICES FOR THE CITY OF ATLANTA, PURSUANT TO SECTION 2-1602 OF THE PROCUREMENT AND REAL ESTATE CODE OF THE CITY OF ATLANTA, FOR THE PURPOSE OF PURCHASING ONLINE AUCTIONEER SERVICES, FOR A TERM OF THREE BASE YEARS WITH AN OPTION TO RENEW FOR AN ADDITIONAL TWO YEAR TERM AT THE SOLE DISCRETION OF THE CITY; ALL REVENUES GENERATED UNDER THIS CONTRACTUAL AGREEMENT SHALL BE DEPOSITED INTO ACCOUNT SEGMENT NUMBERS: 1001 (General Fund), 000002 (Default/Revenue Dept), 3921001 (Proceeds of Sale of Capital) 5501 (Airport Revenue Fund), 000002 (Default/Revenue Dept), 3921001 (Proceeds of Sale of Capital) 5051 (Water & Wastewater Revenue Fund), 000002 (Default/Revenue Dept), 3921001 (Proceeds of Sale of Capital) 5401 (Solid Waste Services Revenue Fund), 000002 (Default/Revenue Dept), 3921001 (Proceeds of Sale of Capital); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") has a need to enhance the sale of municipal surplus property; and

WHEREAS, the Chief Procurement Officer for the Department of Procurement ("DOP") has identified the agreement between the State of Georgia, and The Public Group ("TPG") as a source for a cooperative purchase of online auctioneer services for use by various agencies; and

WHEREAS, pursuant to § 2-1602 of the City of Atlanta Code of Ordinances, the Chief Procurement Officer may procure supplies, services or construction items through contracts established by a public procurement unit where such contracts and contractors substantially meet the requirements of Article X of the Atlanta City Code of Ordinances; and

WHEREAS, the State of Georgia, competitively procured the agreement with TPG in a manner consistent with the City of Atlanta Code of Ordinances; and

WHEREAS, the Commissioner of DOP recommend utilizing the State of Georgia, agreement with TPG, for online auctioneer services for a base term of three (3) years with an option to renew for an additional two (2) year term at the City's sole discretion; and

WHEREAS, all revenues generated under this contractual agreement shall be deposited into account segment numbers: 1001 (General Fund), 000002 (Default/Revenue Dept), 3921001 (Proceeds of Sale of Capital) 5501 (Airport Revenue Fund), 000002 (Default/Revenue Dept), 3921001 (Proceeds of Sale of Capital) 5051 (Water & Wastewater Revenue Fund), 000002 (Default/Revenue Dept), 3921001



(Proceeds of Sale of Capital) 5401 (Solid Waste Services Revenue Fund), 000002 (Default/Revenue Dept), 3921001 (Proceeds of Sale of Capital); and for other purposes.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor, or his designee, on behalf of the City is authorized to enter into cooperative purchasing agreement FC-5566, Online Auctioneer Services for the City of Atlanta, for online auctioneer services for a base term of three (3) years with an option to renew for an additional two (2) year term at the City's sole discretion.

BE IT FURTHER RESOLVED, All revenues generated under this contractual agreement shall be deposited into account segment numbers: 1001 (General Fund), 000002 (Default/Revenue Dept), 3921001 (Proceeds of Sale of Capital) 5501 (Airport Revenue Fund), 000002 (Default/Revenue Dept), 3921001 (Proceeds of Sale of Capital) 5051 (Water & Wastewater Revenue Fund), 000002 (Default/Revenue Dept), 3921001 (Proceeds of Sale of Capital) 5401 (Solid Waste Services Revenue Fund), 000002 (Default/Revenue Dept), 3921001 (Proceeds of Sale of Capital); and for other purposes.

BE IT FURTHER RESOLVED, that the Chief Procurement Officer in consultation with the City Attorney is directed to prepare an appropriate document for execution by the Mayor.

BE IT FINALLY RESOLVED, that the agreement will not become binding on the City, and the City will incur no obligation or liability under it until it has been approved by the City Attorney as to form, executed by the Mayor, attested to by the Municipal Clerk and delivered to The Public Group.
