


AN ORDINANCE BY
COUNCILMEMBER JOYCE SHEPERD

AN ORDINANCE AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY, TO DEPOSIT REVENUE GENERATED BY THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS FROM CERTAIN USE, RENTAL, AND ACTIVITY FEES INTO VARIOUS TRUST ACCOUNTS INDICATED HEREIN; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta's ("City's") Department of Parks, Recreation and Cultural Affairs ("DPRCA") enhances the lives of city of Atlanta residents and visitors by offering programs, services and activities that encourage participation in recreational activities, leisure services and cultural experiences; and

WHEREAS, the City's Code of Ordinances, Section 110-3 ("Fee Schedule") establishes a fee structure for individuals and groups wishing to participate in programs and activities offered by DPRCA; and

WHEREAS, the City's Code of Ordinances, Section 142-103 ("Large Gathering-More than Seventy-Five Attendees) establishes a fee and policy structure for individuals and groups who desire to obtain a large gathering permit; and

WHEREAS, Ordinance 08-O-0877, adopted by the City Council on August 18, 2008 and approved by the Mayor on August 26, 2008 directed that revenue generated from certain use, rental, and activity fees be deposited equally between various general and trust funds; and

WHEREAS, the City desires to direct that all revenue generated from DPRCA programming be now deposited into various Trust Fund Accounts as identified herein.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the FY 2013 budget be amended so that revenue from various DPRCA programming, classes, and activities shall be deposited into specified Trust Accounts.

SECTION 2: That all revenue generated from City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (a)(1) entitled "Gilbert House" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140401 (PRC Cultural Affairs Admin.) 3499002 (Fees-Admin.) 6110000 (Cultural/Recreation Admin.) 600078 (Gilbert House) 69999 (Non Capital Trust).

SECTION 3: That all revenue generated from City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (a)(3) entitled "Fields" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140201 (PRC Parks Administration) 3472002 (Fees, Recreational Activity) 6210000 (Parks Admin.) 600359 (Ground & Site Improvements) 69999 (Non Capital Trust).



SECTION 4: That all revenue, excluding tables, chairs and salary surcharge, generated from City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (a)(4) entitled "Recreation Centers" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140303 (PRC Recreation Administration) 3499002 (Fees- Admin Services) 6190000 (Special Facilities) 600239 (Youth Athletics Program) 69999 (Non Capital Trust).

SECTION 5: That all revenue generated exclusively from table and chair rentals in City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (a)(4) entitled "Recreation Centers" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140303 (PRC Recreation Administration) 3472002(Fees, Recreational Activity) 6190000 (Special Facilities) 600239 (Youth Athletics Program) 69999 (Non Capital Trust).

SECTION 6: That all revenue generated from City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (a)(4)(d) entitled "Salary Surcharge and Security Requirements" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140301 (PRC Recreation Administration) 3472002 (Fees, Recreational Activity) 6110000 (Cultural/Recreation Admin.) XXXXXX (*****) 69999 (Non Capital Trust).

SECTION 7: That all revenue generated from City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (b)(1) entitled " Chastain Arts and Crafts Gallery" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140401 (PRC Cultural Affairs Admin.) 3499002 (Fees-Admin. Services) 6110000 (Cultural/Recreation Admin.) 600071 (Chastain Art Center) 69999 (Non Capital Trust).

SECTION 8: That all revenue generated from City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (b)(2) entitled "South Bend Center of Arts and Culture" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140407 (PRC Southbend Gilbert House Arts Center) 3499002 (Fees-Admin. Services) 6190000 (Special Facilities) 600382 (South Bend Cultural Center Operations) 69999 (Non Capital Trust).

SECTION 9: That all revenue generated from Adult Softball in City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (d)(1)(a) entitled "Adult Athletic Team Registration Fees" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140303 (PRC Recreation Administration) 3472008 (Fees, Baseball) 6190000 (Special Facilities) 600228 (Athletic Operations) 69999 (Non Capital Trust).

SECTION 10: That all revenue generated from Adult Basketball in City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (d)(1)(a) entitled "Adult Athletic Team Registration Fees" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140303 (PRC Recreation Administration) 3472006 (Fees, Basketball) 6190000 (Special Facilities) 600228 (Athletic Operations) 69999 (Non Capital Trust).

SECTION 11: That all revenue generated from City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (d)(3)entitled "After School Tutorial Fee" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140303 (PRC Recreation Administration) 3472005



(Fees, After School Program) 6110000 (Culture/Recreation Administration) 600239 (Youth Athletics Program) 69999 (Non Capital Trust).

SECTION 12: That all revenue generated from City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (e)(1) entitled "Picnic Pavilions" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140201 (PRC Parks Administration) 3472009 (Fees, Pavilion) 6210000 (Parks Administration) 600359 (Ground & Site Improvements) 69999 (Non Capital Trust).

SECTION 13: That all revenue generated from City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (e)(3) entitled "Park Attendant" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140201 (PRC Parks Administration) 3229007 (Park Permit Business Fees) 6210000 (Parks Administration) 600081 (Special Events) 69999 (Non Capital Trust).

SECTION 14: That all revenue, excluding outdoor pool facilities, generated from City Code of Ordinances, Section 110-3 entitled "Fee Schedule" Section (f) entitled "Aquatics Programs" shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140303 (PRC Recreation Administration) 3472004 (Fees, Swimming) 6190000 (Special Facilities) 600239 (Youth Athletics Program) 69999 (Non Capital Trust).

SECTION 15: That all revenue generated from the J.D. Sims Cultural Center shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140302 (PRC Recreation Programs) 3499002 (Fees, Admin Services) 6110000 (Culture/Recreation Administration) 600330 (PRC JD Sims Recreation Center) 69999 (Non Capital Trust).

SECTION 16: That all revenue generated from City Code of Ordinances, Section 142-103 entitled "Large Gatherings- More than Seventy-Five Attendees" Section (d) shall be deposited into ACCOUNT SEGMENT: 7701 (Trust Fund) 140201 (PRC Parks Administration) 3472011 (Fees, Large Gatherings) 6210000 (Parks Administration) 600359 (Ground & Site Improvements) 69999 (Non Capital Trust).

SECTION 17: That all building rental revenue generated at the Dunbar Recreation Center shall be deposited into the same ACCOUNT SEGMENTS as other Class 3 Recreation facilities.

SECTION 18: All ordinances and resolutions in conflict herewith are hereby waived for purposes of this ordinance only, and only to the extent of said conflict.
