AN ORDINANCE TO AUTHORIZE THE MAYOR OR HIS DESIGNEE TO ACCEPT WIRELESS EQUIPMENT AND ENTER INTO AN AGREEMENT WITH VERIZON WIRELESS TO INSTALL, MAINTAIN, AND OPERATE AN IN-BUILDING WIRELESS SERVICE COVERAGE SYSTEM FOR THE CITY OF ATLANTA FACILITY LOCATED AT 72 MARIETTA STREET NORTHWEST, ATLANTA, GEORGIA 30303 AT NO EXPENSE TO THE CITY OF ATLANTA.

WHEREAS, City of Atlanta personnel engaged in public water utility safety have had difficulty getting reception on cellular and radio telecommunications equipment at the City of Atlanta Facility (hereinafter, "Facility") located at 72 Marietta Street Northwest, Atlanta, Georgia 30303; and

WHEREAS, Verizon Wireless ("VAW") LLC d/b/a Verizon Wireless is a telecommunications service provider which provides Wireless Service coverage to the City of Atlanta; and

WHEREAS, Verizon Wireless has agreed to provide, at no cost to the City, in-building equipment at the Facility to improve Wireless Service coverage in the Facility with the use of radio distribution or regeneration equipment, including repeaters, amplifiers, base station equipment, antennas, cables, wiring, and associated network devices, all provided by Verizon Wireless and installed in the Facility for use with Wireless Service provided by Verizon Wireless.

NOW, THEREFORE THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS AS FOLLOWS:

SECTION 1. that the Mayor or his designee is hereby authorized to accept wireless equipment and enter into an In-Building Agreement with Verizon Wireless for the installation, maintenance, and operation of the equipment at the Facility located at 72 Marietta Street Northwest, Atlanta, Georgia 30303.

SECTION 2. that the City of Atlanta accept the installation of the In-Building Wireless Service Coverage System pursuant to Article 1, §1-102(c) (7) of the City of Atlanta Code of Ordinances as a donation.

SECTION 3. that Verizon Wireless is hereby authorized to install the In-Building Wireless Service Coverage System at said facility.

SECTION 4. that the Mayor or his designee is hereby authorized to execute the In-Building Wireless Service Coverage System agreement substantially in the form attached hereto.

SECTION 5. that the In-Building Agreement shall not become binding on the City of Atlanta, nor shall the City of Atlanta incur obligation upon same until such Agreement has been executed by Verizon Wireless, approved by the City Attorney as to form, executed by the Mayor, sealed by the Municipal Court Clerk and duly approved in accordance with the Atlanta City Code.

SECTION 6. that all Ordinances and Resolutions and parts of Resolutions in conflict herewith, except Ordinances and Resolutions relating to applicable permitting and design requirements, are waived for purposes of this Ordinance only, and only to the extent of such conflict.
