


A RESOLUTION**BY: COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE**

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT FOR FC-5987 ON BEHALF OF THE DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT, OFFICE OF PLANNING, WITH THE XYZ CONSULTING GROUP IN AN AMOUNT NOT TO EXCEED ONE HUNDRED THOUSAND DOLLARS AND NO CENTS (\$100,000.00) FOR THE PURPOSE OF DEVELOPING A LIVABLE CENTERS INITIATIVE (LCI) STUDY FOR THE PHASE I BICYCLE ATLANTA PROJECT; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta participates in the Livable Centers Initiative (LCI) program sponsored by the Atlanta Regional Commission; and

WHEREAS, the purpose of the LCI program is to define activity centers in local jurisdictions to help spur public and private investment in new development and in new job growth for the LCI activity center and adjacent neighborhoods when appropriate; and

WHEREAS, the Office of Planning applied for and the Atlanta Regional Commission awarded the City a planning grant in the amount of \$80,000.00 for a bicycle facilities planning study on how to connect residential areas to job centers in the central core of the City; and

WHEREAS, the Bicycle Coalition of Atlanta has provided \$20,000.00 in required project match funds; and

WHEREAS, Ordinance 12-O-0408 authorizes the Mayor to sign a grant agreement with the Atlanta Regional Commission and project funds have been anticipated for this Phase I Bicycle LCI Study.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES that the Mayor be and is hereby authorized to execute a contract for FC-5987 on behalf of the Department of Planning and Development, Office of Planning, with the XYZ Consulting Firm in an amount not to exceed One Hundred Thousand Dollars and No Cents (\$100,000.00) for the purpose of conducting the Phase I Bicycle LCI planning study.

BE IT FURTHER RESOLVED, that all contracted work shall be charged to and paid from the following Intergovernmental Grant Fund: FUND (2501-INTERGOVERNMENTAL FUND) DEPARTMENT (250401 DPCD-PLANNING) ACCOUNT (599999 - PROJECTS AND GRANTS) FUNCTION ACTIVITY (7410000-PLANNING & ZONING) PROJECT (25211315-CYCLE ATLANTA PHASE I-2012) AWARD (250142046-CYCLE ATLANTA PHASE I & 250112059-CYCLE ATL PHASE I -2012 MATCH).

BE IT FURTHER RESOLVED, that the Chief Procurement Officer be and is directed to prepare the appropriate contractual Agreement for execution by the Mayor, and to be approved by the City Attorney as to form.

BE IT FINALLY RESOLVED, that the Agreement authorized hereunder shall not become binding upon the City and the City shall incur no obligation or liability hereunder until the same has been signed by the Mayor, attested to by the Municipal Clerk, and delivered to the contractual party.
