AN ORDINANCE TO TRANSFER SIXTEEN THOUSAND DOLLARS (\$16,000.00) FROM THE DISTRICT 9 COUNCILMEMBER NON-DEPARTMENTAL EXPENSE ACCOUNT AND TWELVE THOUSAND DOLLARS (\$12,000.00) FROM THE DISTRICT 10 COUNCILMEMBER AND NON-DEPARTMENTAL EXPENSE ACCOUNT AND ONE THOUSAND FIVE HUNDRED (\$1,500) FROM THE POST 1 AT LARGE EXPENSE ACCOUNT TO THE DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT TO BE USED TO FUND THE NOMINATION AND DESIGNATION ACTIVITIES PER THE CITY OF ATLANTA'S HISTORIC PRESERVATION ORDINANCE FOR THE COLLIER HEIGHTS NEIGHBORHOOD'S CONSIDERATION AS A LOCALLY DESIGNATED HISTORIC DISTRICT; AND FOR OTHER PURPOSES.

WHEREAS, the Collier Heights neighborhood is on the National Register of Historical Places as an excellent example of a mid 20th century African-American residential, suburban neighborhood; and

WHEREAS, residents and of Collier Heights Neighborhood Association have made numerous requests over the years to have their neighborhood designated as a locally designated Historic District; and

WHEREAS, the Councilmembers from District 9, District 10 and Post 1 At Large, City of Atlanta, have agreed to fund the nomination and designation activities required for consideration as a locally designated Historic District for the Collier Heights Neighborhood; and

WHEREAS, the District 9 Councilmember desires to transfer funds from the District 9 Non-Departmental account to a Planning and Community Development Department project account be used for the nomination and designation activities for the Collier Heights Neighborhood's consideration as a locally designated Historic District; and

WHEREAS, the District 10 Councilmember desires to transfer funds from the District 10 Non-Departmental account to a Planning and Community Development Department project account to be used for the nomination and designation activities for the Collier Heights Neighborhood's consideration as a locally designated Historic District; and

WHEREAS, the Post 1 At Large Councilmember desires to transfer funds from the Post 1 At Large councilmember expense account to a Planning and Community Development Department project account to be used for the nomination and designation activities for the Collier Heights Neighborhood's consideration as a locally designated Historic District; and
