AN ORDINANCE AUTHORIZING THE CITY OF ATLANTA TO WAIVE THE COMPETITIVE SOURCE SELECTION REQUIREMENTS CONTAINED IN SECTION 2-1187 OF ARTICLE X PROCUREMENT AND REAL ESTATE CODE OF THE CITY OF ATLANTA CODE OF ORDINANCES; AND AUTHORIZING CAMERON AND ASSOCIATES TO PROVIDE SERVICES ON A MONTH-TO-MONTH BASIS FOR UP TO SIX (6) MONTHS EFFECTIVE JULY 24, 2012 UNDER THE TERMS OF CONTRACT FC-6008000002, PRE-EMPLOYMENT PSYCHOLOGICAL TESTING, ON BEHALF OF THE DEPARTMENT OF HUMAN RESOURCES, IN AN AMOUNT NOT TO EXCEED FIFTY-ONE THOUSAND DOLLARS AND NO CENTS (\$51,000.00) ALL CONTRACTED WORK TO BE CHARGED TO AND PAID FROM FUND, DEPARTMENT, ORGANIZATION AND ACCOUNT NUMBER: 1001 (GENERAL FUND) 220203 (DHR INSURANCE ADMINISTRATION) 5212001 (CONSULTING/PROFESSIONAL) (\$45,206.00); 5501 (AIRPORT REVENUE FUND) 220203 (DHR INSURANCE ADMINISTRATION) 5212001 (CONSULTING/PROFESSIONAL) (\$5,794.00); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") entered into an agreement with Cameron Associates for FC-6008000002 for employment related psychological testing (the "Agreement") pursuant to Section 2-1140 of Article X of the procurement and Real Estate Code of the City Code of ordinances; and

WHEREAS, the Agreement was for an initial period of three (3) years with two (2) one (1) year renewal options at the City's sole discretion which expired on April 25, 2011; and

WHEREAS, the City executed a ninety (90) day extension, which extended the term to July 23, 2011; and

WHEREAS, the City executed the first one (1) year renewal option, which expired on July 23, 2012; and



WHEREAS, the Department of Human Resources now desires to go through with a new procurement process instead of exercising the last renewal option of the agreement; and

WHEREAS, the City requires employment related psychological testing while it completes the procurement process for a new services agreement; and

WHEREAS, Cameron and Associates has performed satisfactorily under the Agreement; and

WHEREAS, Cameron and Associates is willing to continue providing services under the Agreement so that services at the City go uninterrupted; and

WHEREAS; the Commissioner of the Department of Human Resources and the Chief Procurement Officer recommend that Cameron and Associates be authorized to provide and the City to accept services for the City on a month to month basis for a period of six (6) months effective July 24, 2012 under the terms of the Agreement in an amount not to exceed Fifty-One Thousand Dollars and No Cents (\$51,000.00).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA hereby ordains as follows:

SECTION 1: That Section 2-1187 of Article X Procurement and Real Estate Code of the City of Atlanta Code of Ordinances is waived to the extent of any conflict with this Ordinance.


SECTION 2: That Cameron and Associates is authorized to provide and the City of Atlanta is authorized to accept employment related psychological testing services on a month to month basis effective July 24, 2012 under the terms of the Agreement for a period of six (6) months in an amount not to exceed \$ Fifty-One Thousand Dollars and No Cents (\$51,000.00).

SECTION 3: That authorization is contingent upon adoption of funding outlined herein in the FY2013 budget.

SECTION 4: That all such payments be charged to and paid from FDOA: 1001 (General Fund) 220203 (DHR Insurance Administration) 5212001 (Consulting/Professional Services) 1540000 (Function Activity) – (\$45,206.00); 5501 (Airport Revenue Fund) 220203 (DHR Human Resources Management) 5212001 (Consulting/Professional Services) 1540000 (Function Activity) – (\$5,794.00).

SECTION 5: That all ordinances or parts of ordinances in conflict with this ordinance, including but not limited to Sections 2-1187 of the City of Atlanta Code of ordinances, are waived to the extent of the conflict only.
