A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A RENEWAL TO THE OPERATING AGREEMENT BETWEEN THE CITY OF ATLANTA AND YOUNG MEN'S CHRISTIAN ASSOCIATION OF METROPOLITAN ATLANTA; AND FOR OTHER PURPOSES.

WHEREAS, the Young Men's Christian Association ("YMCA") is a Georgia non-profit corporation dedicated to providing quality community programs to metro Atlanta children; and

WHEREAS, the City of Atlanta ("City") owns and operates the Adamsville Recreation Center ("Center") located at 3201 Martin Luther King Jr. Drive, SW Atlanta, Georgia 30331; and

WHEREAS, the City and YMCA (collectively the "Parties") entered into an Operating Agreement ("Agreement") as authorized by Resolution 11-R-1121, adopted by the City Council on August 15, 2011 and approved as per City Charter Section 2-403 on August 24, 2011 to provide after-school and weekend programs of recreational, educational, and cultural activities for children (collectively the "Services") at the Center, with YMCA serving as a vendor of the City's programs at no cost to the City; and

WHEREAS, the initial term of the Agreement was one year commencing on August 8, 2011, and included an additional one year renewal option by mutual consent of the Parties; and

WHEREAS, the initial one year term will expired on August 7, 2012; and

WHEREAS, the Commissioner of the Department of Parks, Recreation and Cultural Affairs has issued a 90 day extension while the parties exercise the renewal option: and

WHEREAS, the Commissioner of the Department of Parks, Recreation and Cultural Affairs has reviewed and is satisfied with YMCA's performance under the Agreement and desires that the Agreement be extended for an additional year.

WHEREAS, YMCA desires to continue to provide the Services at the Center.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor or his designee, on behalf of the City, is




hereby authorized to enter into a renewal to the Agreement with YMCA to continue providing the Services at the Center.

BE IT FURTHER RESOLVED, that to the extent YMCA is donating time and resources to the City, the City hereby accepts such donation.

BE IT FURTHER RESOLVED, that the City Attorney, or his designee is hereby authorized to prepare the renewal for execution by the Mayor.

BE IT FINALLY RESOLVED, that the renewal shall not become binding on the City, and the City shall incur no obligation or liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney, and delivered to YMCA.
