A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE, ON BEHALF OF THE CITY OF ATLANTA, TO PARTICIPATE WITH PARK PRIDE ATLANTA, INC., IN COMPLETING DETAILED DESIGN AND CONSTRUCTION DOCUMENT PREPARATION FOR THE PROPOSED CENTRAL PLAYGROUND AND SPRAY PAD AREA OF THE REV. JAMES ORANGE PARK, BY PROVIDING AN AMOUNT NOT TO EXCEED THIRTY-FIVE THOUSAND DOLLARS AND NO CENTS (\$35,000.00) TOWARD THE PROJECT; TO BE CHARGED TO AND PAID FROM : 3501 (PARK IMPROVEMENT FUND) 140106 (PRC- PARK DESIGN) 5212001 (CONSULTING/PROFESSIONAL SERVICES) 6220000 (PARKS DESIGN); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") owns Rev. James Orange Park at Oakland City, located at 1305 Oakland Dr. SW., in Council District 4 (the "Park"); and

WHEREAS, the Friends of Rev. James Orange Park have been working to improve the Park, including park workdays, coordinating volunteer opportunities and completing a Vision Plan through Park Pride Atlanta, Inc., ("Park Pride"); and

WHEREAS, as part of the Park improvements being proposed, the Department of Parks, Recreation and Cultural Affairs ("DPRCA") desires to implement the portion of the Vision Plan consisting of a new playground, spray pad, pavilion and garden area in place of the swimming pool and other park improvements in that area of the Park ("Project"); and

WHEREAS, this Project would include replacement of playground equipment at the Park that is at the end of its life cycle and providing a water amenity in the form of a spray pad or "sprayground" which have been highly successful elsewhere in the city; and

WHEREAS, this Project requires detailed design and construction documents to fully investigate what is feasible, to understand costs and allow a concrete vision for fundraising and other purposes; and

WHEREAS, DPRCA desires to partner with Park Pride to provide design management services for the Project given the close working relationship between Park Pride and the community; and

WHEREAS, Park Pride is a 501(c)(3) non-profit organization dedicated to providing support, administration, planning, design and construction services for City parks and DPRCA; and




WHEREAS, DPRCA desires to participate by providing funds in the amount of Thirty-Five Thousand Dollars and No cents (\$35,000.00) to the Project; and

WHEREAS, the City is appreciative of the contributions of Park Pride and finds that it is in the City's best interest to assist in completing the Project at the Park.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor or his designee, on behalf of the City, is authorized to pay an amount not to exceed Thirty-Five Thousand Dollars and No Cents (\$35,000.00) to Park Pride to complete the Project at the Park.

BE IT FURTHER RESOLVED, that the City accepts the contributions of Park Pride at the Park.

BE IT FINALLY RESOLVED, that all funds shall be charged to the following Fund, Department, Organization and Account Number: 3501 (PARK IMPROVEMENT FUND) 140106 (PRC- PARK DESIGN) 5212001 (CONSULTING/PROFESSIONAL SERVICES) 6220000 (PARKS DESIGN); AND FOR OTHER PURPOSES.
