

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE RENEWAL AGREEMENT FOR CONTRACT FC-4811, PARKING OPERATION MANAGEMENT SERVICES WITH STANDARD PARKING CORPORATION ON BEHALF OF THE DEPARTMENT OF AVIATION IN AN AMOUNT NOT TO EXCEED \$59,500,062.00 FOR TWO YEARS; ALL SERVICES TO BE CHARGED TO AND PAID FROM FDOA 5501 (AIRPORT REVENUE FUND) 180304 (DOA AVIATION PARKING) 5212001 (CONSULTING/PROFESSIONAL SERVICES) 7563000 (AIRPORT); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (the "City") owns and operates Hartsfield-Jackson Atlanta International Airport ("Airport"); and

WHEREAS, the City entered into an agreement with Standard Parking Corporation for FC-4811 Parking Operation Management Services, pursuant to Resolution 09-R-0546, adopted by the Council of the City July 6, 2009 and approved by the Mayor July 13, 2009 ("Contract"); and

WHEREAS, the Contract was for an initial term of three (3) years, with a single two (2) year renewal term, such renewal option to be exercised at the sole discretion of the City; and

WHEREAS, the initial term of the Contract is due to expire and the Aviation General Manager has reviewed the performance of Standard Parking Corporation ("Standard Parking") under the Contract and has recommended to the Chief Procurement Officer that the Department of Aviation desires to exercise its option and renew the Contract for the single two (2) year term.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor is authorized to execute Renewal Agreement for FC-4811, Parking Operation Management Services, on behalf of the City of Atlanta with Standard Parking Corporation in the amount not to exceed \$59,500,062.00.

BE IT FURTHER RESOLVED, that the term of such Renewal Agreement will be a single two (2) year period with payments to be disbursed as follows:

Management Fee	\$416,581	\$ 433,244
Operating Expenses (Reimbursable)	\$27,050,145	\$31,600,092
Total	\$27,466,726	\$32,033,336



BE IT FURTHER RESOLVED, that the City Attorney be and is hereby directed to prepare Renewal Agreement with Standard Parking for execution by the Mayor.

BE IT FINALLY RESOLVED, that the Renewal Agreement will not become binding on the City and the City will incur no obligation or liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney, and delivered to Standard Parking Corporation.
