**AN ORDINANCE BY PUBLIC SAFETY AND LEGAL ADMINISTRATION  
COMMITTEE**

**AN ORDINANCE ACCEPTING GRANT MODIFICATIONS TO GRANT AWARD G11GA0003A FROM THE WHITE HOUSE OFFICE OF NATIONAL DRUG CONTROL POLICY (“ONDCP”) AND AMENDING THE 2013 (INTERGOVERNMENTAL GRANT FUND) BUDGET, BY AND ADDING TO ANTICIPATIONS AND APPROPRIATIONS, FIVE THOUSAND, ONE HUNDRED SEVENTY DOLLARS (\$5,170), WITH NO MATCHING FUNDS, BRINGING GRANT AWARD G11GA0003A TO A NEW TOTAL OF FIVE MILLION, SIX HUNDRED FIFTY-FIVE THOUSAND, NINETY-EIGHT DOLLARS (\$5,655,098), FOR THE PURPOSE OF CONTINUING THE ATLANTA HIGH INTENSITY DRUG TRAFFICKING AREA TASK FORCE (“ATLANTA HITDA”); TO DISRUPT AND DISMANTLE DRUG TRAFFICKING ORGANIZATIONS; AND FOR OTHER PURPOSES.**

**WHEREAS**, the White House Office of National Drug Control Policy (“ONDCP”) grants funding to High Intensity Drug Trafficking Area (“HIDTA”) program task forces responsible for disrupting and dismantling violent drug trafficking organizations; and

**WHEREAS**, the Department of Police (“Department”) has been a participant in the Atlanta High Intensity Drug Trafficking Area task force (“Atlanta HIDTA”) for over ten years; and

**WHEREAS**, as per Resolution 05-R-0680, the Atlanta Police Department (“Department”) acts as the “pass through agency” to disburse payments for task force expenses that are completely federally funded, and with no matching funds; and

**WHEREAS**, ONDCP awarded the City another HIDTA grant, number G11GA0003A (“grant award”), in the amount of two million, one hundred twenty-seven thousand, nine hundred twenty-two dollars (\$2,127,922), to continue funding the Atlanta HIDTA task force initiatives which was duly approved of by Council and the Mayor through ordinance 11-O-0927; and

**WHEREAS**, ONDCP modified grant award # G11GA0003A by adding modification #1 to the original grant award of an additional two million, nine hundred thirty-eight thousand, five hundred fifty-nine dollars (\$2,938,559) with no matching funds, bringing the grant award to a new total of five-million, sixty-six thousand, four-hundred, eighty-one dollars (\$5,066,481) and this modification was approved by Council and the Mayor through ordinance 12-O-0046; and

**WHEREAS**, ONDCP further modified grant award # G11GA0003A (“grant award”) through modification #2, that deducts from the grant award five thousand, one hundred seventy dollars (\$5,170) with no matching funds, bringing the total grant award to a new total of five million, sixty-one thousand, three hundred and eleven dollars (\$5,061,311); and

**WHEREAS**, ONDCP further modified grant award # G11GA0003A (“grant award”) modification #3 that adds to the grant award twenty-five thousand, two hundred eighty-four dollars (\$25,284) with no matching funds, bringing the total grant award to a new total of five million, eighty-six thousand, five hundred and ninety-five dollars (\$5,086,595); and



**WHEREAS**, ONDCP further modified grant award # G11GA0003A (“grant award”) modification #4 that adds to the grant award of two hundred thirty thousand dollars (\$230,000) with no matching funds, bringing the total grant award to a new total of five million, three hundred sixteen thousand, five hundred and ninety-five dollars (\$5,316,595); and

**WHEREAS**, ONDCP further modified grant award # G11GA0003A (“grant award”) modification #5 that adds to the grant award of three hundred thirty-three thousand, three hundred thirty-three dollars (\$333,333) with no matching funds, bringing the total grant award to a new total of five million, six hundred forty-nine thousand, nine hundred and twenty-eight dollars (\$5,649,928); and

**WHEREAS**, modifications #2, #3, #4, and #5 were subsequently approved by Council and the Mayor through ordinance 12-O-0583; and

**WHEREAS**, ONDCP further modified grant award # G11GA0003A (“grant award”) modification #6 that adds to the grant award five thousand, one hundred seventy dollars (\$5,170), with no matching funds, bringing the total grant award to a new total of five million, six hundred fifty-five thousand, ninety-eight dollars (\$5,655,098); and

**WHEREAS**, the Department wishes to accept modification #6 to the grant award in order to continue funding the Atlanta HIDTA task force.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS**, as follows:

**SECTION 1:** That the Mayor be and is hereby authorized to accept modification #6 to grant award # G11GA0003A from the White House Office of National Drug control Policy (“ONDCP”) which increases the grant award five thousand, one hundred seventy dollars (\$5,170), with no matching funds, bringing the total grant award to a new total of five million, six hundred fifty-five thousand, ninety-eight dollars (\$5,655,098).

**SECTION 2:** That the 2012 (Intergovernmental Grant Fund) Budget, Department of Police, is hereby amended as follows:
