**AN ORDINANCE AUTHORIZING THE CHIEF FINANCIAL OFFICER TO ESTABLISH A SEPARATE COST CENTER UNDER THE ATLANTA CITY COUNCIL DIRECTOR TO PROPERLY ACCOUNT FOR THE OFFICE OF COMMUNICATIONS; AND FOR OTHER PURPOSES.**

**WHEREAS,** the Council of the City of Atlanta, Georgia, employs a fulltime staff (Council Staff) composed of Research and Policy Analyst, Legislative Assistants and a Communication Staff; and


**WHEREAS,** the Council Staff performs two distinct functions, legislative research and analysis and communications; and

**WHEREAS,** it is the desire of the Director of Council Staff to budget and account for these functions separately; and

**WHEREAS,** the Council Office of Communications needs to have a distinct organizational center to facilitate proper accounting and tracking of financial activity.

**NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, AS FOLLOWS:**

**SECTION 1:** That the Chief Financial Officer is hereby directed to create the necessary Fund, Department, Account and Organization (FDOA) designations, for the Office of Council Communication a follows: (Fund) 1001 (Department) 030302 (Function/Activity) 1120000 and (Accounts) 5111001 (Salaries, Regular), 5121003 (Group Health Ins. Contribution-Emp.), 5121001 (Group Life Ins. Contribution-Emp.), 5124101 (Pension Contribution General Employee Pension Fund), 5124102 (Defined Contribution), 5212001 (Consultant/Professional Services).



**SECTION 2:** That the Fiscal 2013 (General Fund) Budget is amended as follows:




