


AN ORDINANCE

AN ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNEE TO CORRECT THE CITY OF ATLANTA OFFICIAL NEIGHBORHOOD BOUNDARY MAP IN ACCORDANCE WITH ORDINANCE 01-O-1336 FOR MEMORIAL PARK AND TO CONFIRM THE BOUNDARIES BETWEEN BRANDON, MEMORIAL PARK AND WOODFIELD NEIGHBORHOODS IN ACCORDANCE WITH EXHIBIT "A".

WHEREAS, Ordinance 01-O-1336 was adopted by the City Council on October 1, 2001 and approved by the Mayor on October 9, 2001 amending the City’s official neighborhood map to include the boundaries of the Memorial Park neighborhood; and

WHEREAS, Ordinance 07-O-0935 was adopted for the purpose of updating the City’s official Neighborhood Boundary Map (the “Map”) and said map inaccurately depicted the boundaries of the Memorial Park Neighborhood as approved by Ordinance 01-O-1336; and;

WHEREAS, the review of the boundaries will be included on the agenda of NPU C for purposes of discussion and validation to ensure public input on this Ordinance; and

WHEREAS, the correction of the Memorial Park neighborhood boundaries will also confirm the boundaries of the Brandon and Woodfield neighborhoods in accordance with “Exhibit A”.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, AS FOLLOWS:

Section 1. The City Council hereby agrees to authorize the Mayor or his designee to amend the City’s official neighborhood map to depict the boundaries of the Memorial Park neighborhood in accordance with Ordinance 01-O-1336 and to reflect the boundaries of the Brandon and Woodfield Neighborhoods as reflect on “Exhibit A”.

Section 2. All ordinances and portions of ordinances in conflict herewith are hereby rescinded.





AN ORDINANCE

BY COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE

AN ORDINANCE AUTHORIZING THE MAYOR OR HIS DESIGNEE TO RECOGNIZE THE BOUNDARIES OF THE MEMORIAL PARK NEIGHBORHOOD AND TO AMEND THE CITY'S OFFICIAL NEIGHBORHOOD MAP ACCORDINGLY; AND FOR OTHER PURPOSES.

WHEREAS, Resolution 93-R-0058, adopted by the City Council on March 1, 1993, and approved by the Mayor on March 8, 1993, authorized the Mayor or his designee to publish the City's official neighborhood map, entitled "Planning Units for Atlanta's Neighborhoods"; and

WHEREAS, City Code Section 6-3012 defines "neighborhood" as "...a geographic area either with distinguishing characteristics in which the residents have a sense of identity and commonality of perceived interest, or both"; and

WHEREAS, said Section identifies various factors that may contribute to neighborhood identity, including "shared development, history, architecture, social and economic relationships, physical boundaries, and the existence of one or more broadly representative neighborhood organizations devoted to neighborhood preservation and improvement"; and

WHEREAS, the Rolling Acres subdivision was originally platted in 1948 and subsequently incorporated into the Springlake neighborhood at some later date; and

WHEREAS, the Rolling Acres subdivision was designed as a separate and distinct community with no internal streets connecting it to the Springlake neighborhood, a distinctly different platting pattern and zoning designation; and

WHEREAS, the original boundaries of Rolling Acres were Howell Mill Road to the west, Peachtree Creek to the north, Northside Drive to the east, and on the rear property line of those parcels fronting on Longwood Drive to the south, as shown on "Exhibit A" hereto attached as a part to this document; and



WHEREAS, the central feature of Rolling Acres is the Atlanta Memorial Park; and

WHEREAS, the community has petitioned the City to restore the geographic boundaries of the Rolling Acres subdivision to the City's official neighborhood map as the Memorial Park neighborhood; and

WHEREAS, the Commissioner of Planning, Development and Neighborhood Conservation is in agreement with this request; and

WHEREAS the City Council has agreed to amend the official City neighborhood map.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1. The City Council hereby agrees to amend the City's official neighborhood map to include the boundaries of the Memorial Park neighborhood as shown on Exhibit A, hereto attached as part of this document. The City Council authorizes the Mayor or his designee to amend the City's official neighborhood map accordingly.

Section 2. All ordinances and portions of ordinances in conflict herewith are hereby rescinded.




