

A RESOLUTION**BY THE PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ENTER INTO CONTRACT AGREEMENT WITH QUMPUS, INCORPORATION, D/B/A BETTER WORLD BOOKS (BWB) ON BEHALF OF THE DEPARTMENT OF FIRE RESCUE FOR THE PURPOSE OF INSTALLING USED BOOKS DONATION BINS (DROP BOXES) ON THE PROPERTIES OF SELECTED ATLANTA FIRE STATIONS AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta Fire Rescue Department (AFRD) has determine a need to mitigate literacy in the City of Atlanta and improve the quality lives of its citizens; and

WHEREAS, the Atlanta Fire and Rescue fire stations are strategically located throughout the city which will enhance the collections of used books through community donations; and

WHEREAS, BWB wishes to obtain approval to locate one or more used book donation bins ("Drop Box") on the selected fire station properties; and

WHEREAS, the City of Atlanta is willing to grant BWB approval to locate a drop box on the property of selected fire stations in accordance with the terms and conditions provided herein (attachment A).

WHEREAS, BWB is a social enterprise that is in the business of collecting and reselling used books, and providing a substantial portion of the proceeds of such sales to support the efforts of qualified non-profit or charitable organizations dedicated to providing or supporting literacy, books, and reading programs selected by BWB in its own discretion ("Literacy Partners").

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES AS FOLLOWS:

Section 1: that the Mayor or his designee is hereby authorized to enter into a contract agreement with Qumpus, Incorporation, d/b/a Better World Books on behalf of the Department of Fire Rescue for the purpose of installing used books donation bins (drop boxes) on the properties of selected Atlanta Fire Stations.

Section 1: that said agreement will not become binding upon the City and the City will incur no liability or obligation under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney and delivered to the Qumpus, Incorporation.

Section 3: That all resolutions and parts thereof in conflict herewith are hereby waived to the extent of the conflict.
