A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AMENDMENT NO. 1 WITH WWPS, LLC FOR FC-5010, ANNUAL CONTRACT FOR MAJOR MECHANICAL SERVICE AND REPAIRS, ON BEHALF OF THE DEPARTMENT OF WATERSHED MANAGEMENT, TO PROVIDE MAINTENANCE AND MECHANICAL REPAIRS AT DEPARTMENT OF WATERSHED MANAGEMENT FACILITIES IN AN AMOUNT NOT TO EXCEED ONE MILLION, TWO HUNDRED THIRTY-FIVE THOUSAND, FIVE HUNDRED DOLLARS AND NO CENTS (\$1,235,500.00); ALL CONTRACTED WORK WILL BE CHARGED TO AND PAID FROM THE LISTED FUND DEPARTMENT ORGANIZATION AND ACCOUNT NUMBERS IN THE FOLLOWING AMOUNTS: \$400,000.00 - 5051 (WATER & WASTEWATER REVENUE) 170204 (DWM TREATMENT PLANT – RM CLAYTON) 5222002 (REPAIR & MAINTENANCE - EQUIPMENT) 4335000 (SEWAGE TREATMENT), \$242,500.00 - 5051 (WATER & WASTEWATER REVENUE) 170205 (DWM TREATMENT PLANT – UTOY CREEK) 5222002 (REPAIR & MAINTENANCE-EQUIPMENT) 4335000 (SEWAGE TREATMENT), \$203,000.00 - 5051 (WATER & WASTEWATER REVENUE) 170206 (DWM TREATMENT PLANT – SOUTH RIVER) 5222002 (REPAIR & MAINTENANCE - EQUIPMENT) 4335000 (SEWAGE TREATMENT), \$30,000.00 - 5051 (WATER & WASTEWATER REVENUE) 170207 (DWM TREATMENT PLANT – INTRENCHMENT CREEK) 5222002 (REPAIR & MAINTENANCE - EQUIPMENT) 4335000 (SEWAGE TREATMENT), \$30,000.00 - 5051 (WATER & WASTEWATER REVENUE) 170209 (DWM TREATMENT PLANT – PUMPING STATIONS) 5222002 (REPAIR & MAINTENANCE - EQUIPMENT) 4334000 (LIFT STATIONS), \$330,000.00 - 5051 (WATER & WASTEWATER REVENUE) 170407 (DWM WATER - FACILITY MAINTENANCE) 5222001 (REPAIR & MAINTENANCE - BUILDINGS) 4430000 (TREATMENT); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) entered into FC-5010, Annual Contract for Major Mechanical Service and Repairs, with WWPS, LLC (“Agreement”), on behalf of the Department of Watershed Management (“Department”), pursuant to Resolution 10-R-0423; and

WHEREAS, the term of the Agreement is for one (1) year with two (2) one (1) year renewal options to be exercised at the City’s sole discretion; and

WHEREAS, the City authorized Renewal No. 1 of the Agreement with a term of June 16, 2011 to June 15, 2012, pursuant to Resolution 11-R-0367; and

WHEREAS, the City authorized Renewal No. 2 of the Agreement with a term of June 16, 2012 to June 15, 2013, pursuant to Resolution 12-R-0649; and

WHEREAS, the Commissioner of the Department of Watershed Management has identified the need for additional preventative maintenance and mechanical repair services for various equipment (“Services”) located at RM Clayton, Utoy Creek, Intrenchment Creek, South River and various pump station facilities for in an estimated amount not to exceed One Million, Two Hundred Thirty-Five Thousand, Five Hundred Dollars and No Cents (\$1,235,500.00); and



WHEREAS, the Commissioner of the Department of Watershed Management and the Chief Procurement Officer recommend Amendment No. 1 with WWPS, LLC for FC-5010, Annual Contract for Major Mechanical Service and Repairs, to add funding for Services at RM Clayton, Utoy Creek, Intrenchment Creek, South River and various pump station facilities in an amount not to exceed One Million, Two Hundred Thirty-Five Thousand, Five Hundred Dollars and No Cents (\$1,235,500.00).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor, or his authorized designee, is authorized to enter into Amendment No. 1 with WWPS, LLC for FC-5010, Annual Contract for Major Mechanical Service and Repairs, to add funding for preventative maintenance and mechanical repair services for various equipment located at RM Clayton, Utoy Creek, Intrenchment Creek, South River and various pump station facilities in an amount not to exceed One Million, Two Hundred Thirty-Five Thousand, Five Hundred Dollars and No Cents (\$1,235,500.00).

BE IT FURTHER RESOLVED, that the Chief Procurement Officer, in consultation with the City Attorney, is directed to prepare all appropriate documents for execution by the Mayor or his authorized designee.

BE IT FURTHER RESOLVED, that Amendment No. 1 will not become binding on the City and the City will incur no obligation or liability under Amendment No. 1 has been executed by the Mayor, or his authorized designee, attested to by the Municipal Clerk, approved as to form by the City Attorney and delivered to WWPS, LLC.
