**A RESOLUTION
BY TRANSPORTATION COMMITTEE**

RESOLUTION AUTHORIZING THE MAYOR TO APPROVE AN AMENDMENT TO FC-5236 FOREIGN CURRENCY EXCHANGE SERVICES – CONCOURSES E & F TO APPROVE THE CONCESSIONAIRE INCENTIVE TO TRAVELEX CURRENCY SERVICES, INC. FOR ITS CONCOURSE F CONSTRUCTION COMPLETION AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) owns and operates Hartsfield-Jackson Atlanta International Airport (“Airport”); and

WHEREAS, pursuant to a competitive sealed proposal process in accordance with City of Atlanta Code of Ordinances Section 2-1189, Travelex Currency Services, Inc. (“Travelex”) was awarded a lease agreement at the Airport; and

WHEREAS, the City and Travelex entered into the lease agreement allowing Travelex to operate Foreign Currency Exchange services at its Concourse “E” and “F” locations in the Maynard H. Jackson International Terminal (“MHJIT”); and

WHEREAS, due to circumstances beyond the City’s control, construction of the concession space was delayed; and

WHEREAS, due to unexpected additional construction costs incurred by all concessionaires located on Concourse “F”, and in the MHJIT, the City instituted an incentive program providing that if the concessionaire had completed construction and was ready for business on or before May 16, 2012, the concessionaire was entitled to operate its Concourse “F” locations rent-free for the first three (3) months, solely with respect to the locations that are open and operating on May 16, 2012 (“Concessionaire Incentive”); and

WHEREAS, Travelex, at its sole cost and expense, completed construction and was ready for business on or before May 16, 2012; and

WHEREAS, the Travelex locations that were eligible for the Concessionaire Incentive are identified as F-C1, F-C2, F-C3; and

WHEREAS, after qualifying for the Concessionaire Incentive, Travelex did in fact pay rent to a third party Airport tenant; and

WHEREAS, it is in the best interest of the City to honor the Concessionaire Incentive.



NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, that the Mayor is authorized on behalf of the City to execute Amendment No. 1 to FC-5236 Foreign Currency Exchange Services – Concourses E & F to approve the Concessionaire Incentive to Travelex for its Concourse “F” construction completion.

BE IT FURTHER RESOLVED that the City Attorney is directed to prepare appropriate agreements for execution by the Mayor.

BE IT FINALLY RESOLVED that said amendments shall not become binding upon the City, and the City shall incur no obligation or liability until same has been signed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney and delivered to the appropriate concessionaire.
