**AN ORDINANCE ESTABLISHING THE SALARIES FOR THE
MAYOR, COUNCIL PRESIDENT AND CITY COUNCIL
MEMBERS FOR THE TERMS OF OFFICE BEGINNING
JANUARY 2014; AND FOR OTHER PURPOSES**

WHEREAS, the City of Atlanta Elected Officials Compensation Commission (the "Commission") was created pursuant to Section 2-701 of the City Charter; and

WHEREAS, the Commission was most recently populated in 2012 in accordance with Section 2-702 of the City Charter; and

WHEREAS, the Commission engaged the services of a consultant to conduct surveys regarding the salaries of elected officials in cities similar to Atlanta in terms of population and governmental structure, interviewed City of Atlanta elected officials, discussed and debated the issue of salaries for elected officials of the City of Atlanta; and

WHEREAS, a public hearing was held on July 30, 2012 at 6:00 p. m. as required by Section 2-703 of the City Charter; and

WHEREAS, the Commission has completed its task and on October 31, 2012, submitted its report and recommendations to the Mayor, Council President, City Council members and the members of the Atlanta Board of Education, regarding the amount of compensation which it deems appropriate for the Mayor, Council President, City Council members and members of the Atlanta Board of Education, which was at least one year prior to the next regular municipal election as prescribed in Section 2-703 of the Charter; and

WHEREAS, any action by the City Council resulting in a salary change shall not become effective until the date of commencement of the terms of office of the officials elected at the next regular municipal election following the date of any such action; and

WHEREAS, pursuant to Section 2-306 (a) (2) of the Charter of the City of Atlanta, no action to increase such salaries shall be taken until notice of intent to take the action has been published in a newspaper of general circulation designated as the legal organ in the county and in the city at least once a week for three consecutive weeks immediately preceding the week during which the action is taken; and



WHEREAS, the current salaries for the Mayor, Council President and City Council members, set in 2005, are \$147,500.00, \$41,000.00 and \$39,473.00, respectively; and

WHEREAS, in its deliberation of this ordinance, the Atlanta City Council, has taken into consideration, the report and recommendations of the Commission regarding the salaries which it deems appropriate for the Mayor, Council President, and City Council members who will take office on January 2014.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA that the following salaries are hereby adopted for elected officials of the City of Atlanta, Georgia for the terms of office beginning January 2014.

Council President	\$ 62,000.00
Council members	\$ 60,300.00

BE IT FURTHER ORDAINED that all ordinances and parts of ordinances in conflict herewith are hereby repealed.
