**A RESOLUTION AUTHORIZING RENEWAL NO. 2 WITH MACK'S HAULING, INC. FOR FC-6006007938C, CITYWIDE DEMOLITION SERVICES, ON BEHALF OF THE DEPARTMENT OF WATERSHED MANAGEMENT; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta ("City") authorized FC-6006007938C, Citywide Demolition Services ("Agreement") with Mack's Hauling, Inc., on behalf of the Department of Planning and Community Development, pursuant to Resolution 07-R-1483; and

**WHEREAS**, the term of the agreement is for three (3) years with two (2) one (1) year renewal options to be exercised at the City's sole discretion; and

**WHEREAS**, the City authorized Amendment Agreement No. 1 to add funding for citywide demolition services in an amount not to exceed Nine Hundred Thousand Four Hundred Ninety Two Dollars and Fourteen Cents (\$900,492.14), pursuant to 07-R-2451; and

**WHEREAS**, the City authorized Amendment Agreement No. 2 to add the Department of Parks, Recreation and Cultural Affairs as an additional authorized user of services in an amount not to exceed Seven Hundred Thousand Dollars and Zero Cents (\$700,000.00), pursuant to Resolution 08-R-1871; and

**WHEREAS**, the City authorized Amendment Agreement No. 3 to add funding for citywide demolition services in an amount not to exceed One Million, One Hundred Thousand, Four Hundred Seventy Seven Dollars and Seventy Eight Cents (\$1,100,477.78), pursuant to Resolution 09-R-1389; and

**WHEREAS**, the City authorized Amendment Agreement No. 4 to add funding for citywide demolition services in an amount not to exceed One Hundred Ninety Thousand Dollars and Zero Cents (\$190,000.00), pursuant to Resolution 09-R-1388; and

**WHEREAS**, the City authorized Amendment Agreement No. 5 to add the Department of Watershed Management as an additional authorized user of services in an amount not to exceed Three Hundred Three Thousand Five Hundred Ninety-Eight Dollars and Zero Cents (\$303,598.00), pursuant to Resolution 11-R-1594; and

**WHEREAS**, the City authorized Renewal No.1 of the Agreement with a term of December 21, 2011 to December 20, 2012, pursuant to Resolution 11-R-1584; and

**WHEREAS**, the City authorized Amendment Agreement No. 6 to add funding for citywide demolition services in an amount not to exceed One Hundred Thousand Dollars and Zero Cents (\$100,000.00), pursuant to Resolution 11-R-1709; and

**WHEREAS**, Mack's Hauling, Inc. continues to satisfactorily perform services under the Agreement; and



**WHEREAS**, the Commissioner of the Department of Watershed Management and the Chief Procurement Officer recommend authorizing the City's option for Renewal No. 2 with Mack's Hauling, Inc. for FC-6006007938C, Citywide Demolition Services for an additional one (1) year term with no additional funding appropriated for this renewal term.

**THE CITY COUNCIL OF THE CITY OF, ATLANTA GEORGIA, HEREBY RESOLVES**, that the Mayor, or his authorized designee, is authorized to exercise the City's option for Renewal No. 2 with Mack's Hauling, Inc. for FC-6006007938C, Citywide Demolition Services, on behalf of the Department of Watershed Management, for an additional one (1) year term with no additional funding appropriated for this renewal term;

**BE IT FURTHER RESOLVED**, that the term of Renewal No. 2 will be from December 21, 2012 to December 20, 2013;

**BE IT FURTHER RESOLVED**, that the Chief Procurement Officer, in consultation with the City Attorney, is directed to prepare all appropriate documents for execution by the Mayor, or his authorized designee; and

**BE IT FINALLY RESOLVED**, that Renewal No. 2 will not become binding on the City, and the City will incur no obligation or liability under it until all appropriate documents have been duly executed by the City and delivered to Mack's Hauling, Inc.
