A RESOLUTION ADOPTING FIVE YEAR PLAN UPDATES TO THE BANKHEAD MARTA TRANSIT AREA, SOUTH MORELAND AVENUE, PONCE DE LEON AND MORELAND AVENUES LIVABLE CENTERS INITIATIVE PLANS (LCI) AS REQUIRED BY THE ATLANTA REGIONAL COMMISSION (ARC); AUTHORIZING THE DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT, ON BEHALF OF THE CITY OF ATLANTA, TO SUBMIT TO THE ARC THE RESPECTIVE FIVE YEAR UPDATE PLANS; AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta Regional Commission's (ARC) Livable Centers Initiative (LCI) program encourages local governments to create plans that link transportation improvements with land use development strategies to create mixed use communities consistent with regional development policies.

WHEREAS, the ARC previously awarded the City of Atlanta grant funds to conduct LCI plans for the Bankhead MARTA Transit Area and the South Moreland Avenue and also grandfathered the Ponce de Leon and the Moreland Avenue LCI Plans; and

WHEREAS, the Office of Planning previously completed each of these four LCI Plans and the Atlanta City Council adopted them into the City's Comprehensive Development Plan pursuant to Resolutions 06-R-0588 (Bankhead MARTA Transit Area), 08-R-1039 (South Moreland Avenue) and 05-R-1235 (Ponce de Leon and Moreland Avenue LCI's); and

WHEREAS, the Atlanta Regional Commission (ARC) requires local governments to adopt, by resolution, a five year update that includes an Evaluation and Appraisal Report and an Implementation Plan with an updated five (5) year Action Plan to be submitted five years after the plan is approved by the ARC ("LCI Five Year Plan Update"); and

WHEREAS, the LCI Five Year Plan Update are now due to the ARC for each of the aforementioned LCI Plans.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES to adopt the Bankhead MARTA Transit Area LCI Five Year Plan Update, attached hereto as Exhibit "A".

BE IT FURTHER RESOLVED to adopt the South Moreland Avenue LCI Five Year Plan Update, attached hereto as Exhibit "B".

BE IT FURTHER RESOLVED to adopt the Ponce de Leon LCI Five Year Plan Update, attached hereto as Exhibit "C".

BE IT FURTHER RESOLVED to adopt the Moreland Avenue LCI Five Year Plan Update, attached hereto as Exhibit "D".

BE IT FINALLY RESOLVED that the Department of Planning and Community Development is authorized to submit each of the LCI Five Year Plan Update reports to the Atlanta Regional Commission.
