A RESOLUTION AUTHORIZING THE ATLANTA CITY COUNCIL TO APPOINT A MEMBER OF COUNCIL TO THE BOARD OF DIRECTORS OF THE CITY OF ATLANTA SOLID WASTE MANAGEMENT AUTHORITY, TO REPEAL CONFLICTING RESOLUTIONS; AND FOR OTHER PURPOSES.

WHEREAS, on September 20, 1993 the Council of the City of Atlanta passed legislation to activate the City of Atlanta Solid Waste Management Authority pursuant to the Regional Solid Waste Management Authorities Act (Code 1981, §12-8-50), enacted by Ga. (1990, p. 412, §1.); and

WHEREAS, Section 2-1852 requires the Municipal Clerk to follow certain procedures upon knowledge of a vacancy on a board, commission or authority; and

WHEREAS, the City of Atlanta Solid Waste Management Authority has not met in several years and several positions are vacant and need to be reappointed including a member of the Atlanta City Council.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That Council Member Aaron Watson is hereby appointed to the Board of Directors of the City of Atlanta Solid Waste Management Authority.

SECTION 2: That all resolutions and parts of resolutions in conflict herewith be and the same are hereby waived to the extent of the conflict.
