AN ORDINANCE

BY COUNCILMEMBER KWANZA HALL

AS SUBSTITUTED BY TRANSPORTATION COMMITTEE

A SUBSTITUTE ORDINANCE TO REVISE TAXICAB STANDS ON THE SOUTH SIDE OF MARTIN LUTHER KING JR., DRIVE BETWEEN PEACHTREE STREET AND BROAD STREET AND TO REPLACE SOME OF THE TAXICAB STANDS WITH METERED PARKING; AND FOR OTHER PURPOSES.

WHEREAS, there currently exist approximately seven (7) parking spaces along the south side of Martin Luther King Jr. Drive between Peachtree Street and Broad Street which are dedicated to taxicab stands; and

WHEREAS, residents of the South Broad Street area, which is part of the South Central Business District, are increasingly concerned about illegal activity in the area; and

WHEREAS, residents of the area feel the taxicab stands in the area contributes to the accessibility to the neighborhood of undesirable elements; and

WHEREAS, the City can benefit financially by replacing some of the seven (7) taxicab stands with metered parking spaces.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

SECTION 1: That approximately five (5) of the seven (7) parking spaces along the south side of Martin Luther King Jr. Drive between Peachtree and Broad Streets currently dedicated to taxicab stands, no longer be designated as taxicab parking.

SECTION 2: That approximately five (5) of the spaces along Martin Luther King Jr. Drive currently designated as taxicab parking be converted to metered parking and revenues collected for the benefit of the City.

SECTION 3: That two (2) of the seven (7) spaces currently dedicated for taxicab stands and located nearest to Peachtree Street be retained for taxicab stands.

SECTION 4: That all ordinances and parts of ordinances in conflict herewith be, and the same are hereby repealed.
