**AN ORDINANCE AUTHORIZING PAYMENT TO LIVEVABLE BUCKHEAD IN THE AMOUNT OF \$10,000.00, FROM THE DISTRICT 8 COUNCILMEMBER CARRYFORWARD IN THE NON-DEPARTMENTAL RESERVES TO ASSIST WITH THE 2013 BUCKHEAD ECO COLLECTION EVENT; AND FOR OTHER PURPOSES.**

**WHEREAS**, Livable Buckhead, a non-profit organization, has formed with the purpose of ensuring long-term viability and prosperity by working cooperatively with individuals, public entities and private businesses in order to promote and integrate sustainable strategies in the Buckhead Community; and

**WHEREAS**, one of Livable Buckhead's first events to encourage sustainability by recycling and proper waste disposal will be an Eco Collection Event, which they will co-host with Live Thrive, another non-profit dedicated to helping others make healthy changes in their community's environment; and

**WHEREAS**, the Buckhead Eco Collection Event will take place on March 23<sup>rd</sup> and will have vendors that recycle and properly dispose of items including (but not limited to) paper, paint, medication, electronics, printer cartridges, batteries and fluorescent bulbs; and

**WHEREAS**, being that this is the third Buckhead Eco Collection Event, fundraising has been necessary and limited making a donation from District 8 Office crucial; and

**WHEREAS**, there are some funds available within the District 8 Councilmember Carryforward in the Non-Departmental Reserves that can be contributed to the 2013 Buckhead Eco Collection Event.

**NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, as follows:

**SECTION 1:** That the Chief Financial Officer is authorized to remit payment to Livable Buckhead for the 2013 Buckhead Eco Collection Event in the amount of \$10,000.00.

**SECTION 2:** That all payments shall be charged to and made from the following:
