Imam Plemon T. El-Amin has served for the past 24 years as the Resident Imam of the Atlanta Masjid of Al-Islam, one of the largest and most progressive Mosques in the United States. With his leadership, the Atlanta Masjid developed the fully accredited and acclaimed Clara Mohammed Elementary and W. Deen Mohammed High Schools in East Atlanta. Imam El-Amin is the Director of World Pilgrims, an interfaith effort to develop trust, friendships, understanding, and cooperation among faith leaders through travel and exchange. He was appointed to the City of Atlanta and Fulton County Recreation Authority Board by Mayor Shirley Franklin.

Imam El-Amin is currently a board member of the Atlanta Interfaith Broadcasters (AIB), the Faith Alliance of Metro Atlanta (FAMA), the Atlanta Police Foundation, and the Atlanta Majlis Ash-Shura (Council of Imams). He has performed the Pilgrimage to Mecca (Hajj) twice in 1978 and 2006, and has travelled internationally extensively.

He is a native of Atlanta, a graduate of Booker T. Washington High (1968) and of Harvard University (1972). He is married to Cassandra Scott El-Amin and is the father of two adult children, Attorney Fatima El-Amin (Atlanta) and Fareed Abdullah El-Amin (Chicago), and the grandfather of Haneef (7), Sultan (5), and Naja (4).
