**AN ORDINANCE
BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

AN ORDINANCE TO AMEND THE 2013 INTERGOVERNMENTAL GRANT FUND BUDGET, DEPARTMENT OF POLICE (“DEPARTMENT”), BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TWENTY-TWO THOUSAND, ONE HUNDRED FORTY-THREE DOLLARS AND TWENTY-TWO CENTS (\$22,143.22) FROM A GRANT AWARD FROM THE UNITED STATES DEPARTMENT OF JUSTICE, AND TWENTY-TWO THOUSAND, ONE HUNDRED FORTY-THREE DOLLARS AND TWENTY-TWO CENTS (\$22,143.22) IN MATCHING FUNDS FROM THE CITY OF ATLANTA, GEORGIA, TOTALLING FORTY-FOUR THOUSAND, TWO HUNDRED EIGHTY-SIX DOLLARS AND FORTY-FOUR CENTS (\$44,286.44); TO PURCHASE BULLET-PROOF VESTS FOR THE ATLANTA POLICE DEPARTMENT; AND FOR OTHER PURPOSES.

WHEREAS, the United States Department of Justice awarded the Atlanta Police Department (“Department”) a grant in the amount of twenty-two thousand, one hundred forty-three dollars and twenty-two cents (\$22,143.22) to reimburse the department half the cost of the purchase of bulletproof vests to protect sworn police officers; and

WHEREAS, the grant includes matching funds of twenty-two thousand, one hundred forty-three dollars and twenty-two cents (\$22,143.22), and the Department has identified the matching fund to be a portion of the department’s 2013 budget: 1001 (General Fund); 240201 (APD Police Administration); 5710001 (Payment to Others); 3210000 (Police Administration); and

WHEREAS, the Department wishes to enter into the grant, in order to reduce the costs of purchasing bulletproof vests.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the Mayor or his designee, be and is hereby authorized to accept a grant from the United States Department of Justice, in the amount of twenty-two thousand, one hundred forty-three dollars and twenty-two cents (\$22,143.22); for the purpose of reimbursing the Atlanta Police Department half the cost of purchasing bulletproof vests to protect sworn police officers.

SECTION 2: That the 2013 (Intergovernmental Grant Fund) Budget, Department of Police is hereby amended as follows:


