AN ORDINANCE AMENDING THE 2013 TRUST FUND BUDGET, TO REIMBURSE THE ATLANTA POLICE DEPARTMENT (“POLICE DEPARTMENT”) FOR COSTS ASSOCIATED WITH THE RED LIGHT TRAFFIC CAMERA PROGRAM, BY TRANSFERRING BETWEEN ACCOUNTS THE SUM OF FIFTY-SEVEN THOUSAND, EIGHT HUNDRED TWENTY-SIX DOLLARS AND SIXTY-TWO CENTS (\$57,826.62); AND FOR OTHER PURPOSES.

WHEREAS, The Department of Public Works (“Public Works”) collected fines associated with the Red Light Traffic Camera program, in accordance with 09-R-1711; and

WHEREAS, in accordance with 09-R-1711, sworn police officers from the Atlanta Police Department (“Police Department”), provided red light traffic camera citation issuance and certification under the Red Light Traffic Camera program; and

WHEREAS, the cost to the Police Department of the officers providing red light traffic camera citation issuance and certification under the Red Light Traffic Camera Program amounted to fifty-seven thousand, eight hundred twenty-six dollars and sixty-two cents (\$57,826.62); and

WHEREAS, the Police Department has not collected any funds from Public Works to cover the costs associated with the sworn police officers providing Red Light Traffic Camera Program citation issuance and certification; and

WHEREAS, the Police Department has requested reimbursement for those costs in accordance with 09-R-1711; and

WHEREAS, in accordance with 09-R-1711 all expenses generated from the program shall be paid from account number: 7701 (Trust Fund), 130308 (DPW Transportation Design), 5239004 (Service Grants) or successor accounts.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA GEORGIA, AS FOLLOWS:


