AN ORDINANCE BY

COUNCILMEMBER MICHAEL J. BOND

AN ORDINANCE TO REAUTHORIZE THE EXTENSION OF ALL PERMITS FOR VENDING ON PUBLIC PROPERTY ISSUED IN 2003 AND NOT CURRENTLY SUBJECT TO RENEWAL TO _____, 20____; TO WAIVE CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, certain permits authorizing vending on public property are scheduled to expire on December 31, 2012; and

WHEREAS, these public property vending permits are not subject to renewal under the current public property vending Ordinances.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS, as follows:

Section 1: Any permits issued pursuant to Chapter 30, Article XXIII of the City of Atlanta code of Ordinances for the purpose of vending on public property during calendar year 2003, which are currently not subject to renewal, are hereby reauthorized and extended and shall remain in effect and valid through _____, 20____. All current permit holders subject to extension shall be required to pay a prorated permit fee in proportion to the length of the extension.

Section 2: This ordinance shall take effect immediately.

Section 3: That all ordinances and parts of ordinances in conflict herewith are hereby waived to the extent of the conflict.
