TRANSFERRING FUNDS FROM THE DISTRICT 8 COUNCILMEMBER CARRY FORWARD ACCOUNT IN THE NON-DEPARTMENTAL RESERVES IN AN AMOUNT OF \$5,000.00 TO PARK PRIDE ON THE BEHALF OF THE WILDWOOD CIVIC ASSOCIATION TO ASSIST IN THE INSTALLATION OF A GAZEBO WITHIN BEAVERBROOK PARK; AND FOR OTHER PURPOSES.

Whereas, members of the Wildwood Civic Association and neighbors within the Wildwood Neighborhood have worked hard to raise money via donations and grants in order to install a gazebo within Beaverbrook Park, a City of Atlanta park located within the Wildwood Neighborhood; and

Whereas, the planned commercial-grade gazebo will be a wonderful asset to the park and will add a more passive area near the playground already within the park; and

Whereas, the Department of Parks, Recreation and Cultural Affairs supports the project, which has received a dollar for dollar grant from Park Pride totaling \$9,000.00; and

Whereas, to date, residents of the Wildwood Neighborhood have donated \$2,785.14 towards the gazebo project; and

Whereas, due to the overall cost of \$16,000.00, for the gazebo, the Neighborhood Association and their partners are still lacking funds for the entire project; and

Whereas, an account with Park Pride for the project already exists to which District 8 office funds can be transferred.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Chief Financial Officer is authorized to remit payment to the Beaverbrook Park Gazebo account in the amount of \$5,000.00, to go towards the installation of a gazebo within Beaverbrook Park.

SECTION 2: That all payments shall be charged to and made from the following:
