**A SUBSTITUTE RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY OF ATLANTA TO EXECUTE CONTRACT FC-6677 MARIETTA STREET CITY GALLERY REDESIGN WITH DIAMOND DEVELOPMENT, INC., FOR THE PURPOSE OF REDESIGNING THE GALLERY SPACE LOCATED AT 72 MARIETTA STREET ON BEHALF OF THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS, IN AN AMOUNT NOT TO EXCEED SEVEN HUNDRED FIFTY THOUSAND DOLLARS AND NO CENTS (\$750,000.00); ALL CONTRACTED WORK TO BE CHARGED TO AND PAID FROM A FISCAL YEAR 2014 BUDGET ALLOCATION; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta (the "City") Department of Parks, Recreation and Cultural Affairs ("DPRCA") solicited Bids/Proposals for Contract FC-6677, Marietta Street City Gallery Redesign ("Contract") to redesign the lobby of the City-owned 72 Marietta Street gallery space (the Project"); and

**WHEREAS**, after reviewing and evaluating the Bids/Proposals, the Director of the Office of Cultural Affairs and the Chief Procurement Officer recommend that the Contract be awarded to Diamond Development, Inc. ("Contractor"), in an amount not to exceed Seven Hundred Fifty Thousand Dollars and No Cents (\$750,000.00); and

**WHEREAS**, the term of the Contract between the City and Contractor shall be for a period of 100 days for final completion from issuance of the notice to proceed in an amount not to exceed Seven Hundred Fifty Thousand Dollars and No Cents (\$750,000.00); and

**WHEREAS**, the Director of the Office of Cultural Affairs and the Chief Procurement Officer have determined that it is desirable and in its best interest of the City to enter into the Contract with the Contractor.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES**, that the Mayor, on behalf of the City is authorized to execute Contract FC-6677, Marietta Street City Gallery Redesign with the Contractor on behalf of DPRCA in an amount not to exceed Seven Hundred Fifty Thousand Dollars and No Cents (\$750,000.00) with a term of 100 days for final completion from issuance of the notice to proceed.

**BE IT FURTHER RESOLVED**, that all this Contract shall be contingent upon a Fiscal Year 2014 Budget allocation.



**BE IT FURTHER RESOLVED**, that the Chief Procurement Officer is directed to assist the City Attorney in the preparation of the Contract for execution by the Mayor.

**BE IT FINALLY RESOLVED**, that the Contract will not become binding upon the City, and the City will incur no liability under it until the Contract is executed by the Mayor, attested to by the Municipal Clerk, approved by the City Attorney as to form and delivered to Diamond Development, Inc.
