

**BY PUBLIC SAFETY AND LEGAL ADMINISTRATION COMMITTEE**

**A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ENTER INTO MEMORANDA OF UNDERSTANDING AND OTHER CONTRACTUAL AGREEMENTS TO ALLOW INSTALLATION OF SURVEILLANCE CAMERAS ON STRATEGIC FACILITIES AROUND THE CITY OF ATLANTA IN ORDER TO EXPAND THE CITY'S PUBLIC SAFETY SYSTEM; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta ("City") desires to expand the footprint of its public safety video surveillance system; and

**WHEREAS**, the City seeks to create a best of class Video Integration Center ("VIC") to manage public safety video surveillance; and

**WHEREAS**, City desires to gain access to real-time, visual image data ("Public Access VID") for the Atlanta Police Department (APD) through cameras at different locations throughout the City of Atlanta including on poles, buildings and other facilities ("Facilities"); and

**WHEREAS**, the City Council of Atlanta approved 11-R-1017 on 18 July 2011, and it was subsequently approved by the Mayor as per City Charter Section 2-403 on 27 July 2011, that authorized the Mayor or his designee to enter into Memoranda of Understanding and other Contractual Agreements to access video surveillance equipment and other communications equipment at various buildings around the City of Atlanta in order to expand the City Video Integration Center ("VIC"); and

**WHEREAS**, 11-R-1017 solely authorized memoranda of understanding and contractual agreements related to access at buildings, and the City desires access at additional types of locations besides buildings, including, but not limited to, on poles and various other facilities; and

**WHEREAS**, various parties wish to share the Public Access VID to assist the City in emergency management efforts for purposes of disaster mitigation and public safety, and

**WHEREAS**, City of Atlanta, the Atlanta Police Foundation and other parties ("Parties") desire to enter into agreements setting forth the Parties' understanding of certain terms and conditions relating to the sharing of the Public Access VID, and

**WHEREAS**, Parties, including the public safety components within federal, state and local agencies, authorities and entities have requested access to facilities around the City for surveillance cameras which they will share Public Access VID with the City, and

**WHEREAS**, the Department of Public Works maintains some of the Facilities where cameras will be placed.



**NOW THEREFORE, BE IT RESOLVED BY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, AS FOLLOWS:**

**SECTION 1:** That the Mayor or his designee be and is hereby authorized to enter into Memoranda of Understanding and other Contractual Agreements to allow installation of video surveillance equipment and other communications equipment at various Facilities around the City of Atlanta in order to expand our Video Integration Center.

**BE IT FURTHER RESOLVED,** that the City Attorney is directed to prepare appropriate agreements for execution by the Mayor or his designee to expand video surveillance at the City of Atlanta.

**BE IT FURTHER RESOLVED,** that the agreement will not become binding upon the City and the City will incur no obligation or liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney and delivered to the various Parties in the City of Atlanta.


