I, Frank Poe, Executive Director of the Georgia World Congress Center Authority (GWCCA) commit to serving on the Downtown Development Technical Advisory Group as the representative for GWCCA.

Frank Poe (Bio)

Frank Poe currently serves as the Executive Director of the Georgia World Congress Center (GWCC).

Poe, started his career at the Dallas Convention Center in 1972 as a part-time laborer. He was appointed general manager of the Orange County Convention Center in Orlando, Fla., from 1979 to 1980. He went back to Dallas and for the next 17 years held several leadership positions in the center's event services and cultural affairs departments. He then became executive director of Alabama's Birmingham-Jefferson Convention Complex in 1997, which he held for seven years until moving back to Dallas in 2004 to assume the director position for the next six years.

As director of the Dallas Convention Center, Poe had fiscal control of an annual budget of more than \$60 million and was responsible for the management of the Dallas Convention Center, Reunion Arena, Dallas Farmer's Market, Union Station and the Office of Special Events.

Poe began his tenure at GWCC in April of 2010. The Georgia World Congress Center, Georgia Dome and Centennial Olympic Park welcomed more than 6.4 million visitors in fiscal 2009. Those visitors put \$1.4 billion new dollars into Georgia's economy and generated \$2.2 billion total economic impact and \$171 million in new tax revenue.
