

**AN ORDINANCE
BY COUNCILMEMBER(S) BOND, HALL, WINSLOW, YOUNG JR.
AMENDED BY TRANSPORTATION COMMITTEE**

AN ORDINANCE BY COUNCILMEMBERS MICHAEL J. BOND, KWANZA HALL, CLETA WINSLOW AND IVORY LEE YOUNG, JR. AS AMENDED BY TRANSPORTATION COMMITTEE TO PLACE A MORATORIUM ON THE ISSUANCE OF TEMPORARY PARKING LOT PERMITS IN THE CASTLEBERRY HILL NEIGHBORHOOD FOR A PERIOD NOT TO EXCEED 180 DAYS; TO AUTHORIZE THE DEPARTMENT OF PUBLIC WORKS TO REVIEW AND MAKE RECOMMENDATIONS FOR THE ISSUANCE OF SUCH PERMITS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta is authorized by Chapter 150 (“Traffic and Vehicles”), Article II (“Administration and Enforcement”), Section 150-26 (“Temporary and Experimental Regulations”) of the Code of Ordinances to make and enforce temporary or experimental off-street parking regulations to address emergencies or special conditions; and,

WHEREAS, it is in the interest of the public health, safety and welfare of the City of Atlanta’s citizens and visitors that the Department of Public Works periodically review and enhance said regulations; and,

WHEREAS, a moratorium for a period not exceed 180 days shall apply to the area bounded by the following streets:

- Northern boundary: Martin Luther King, Jr. Drive, SW
- Western boundary: Northside Drive, SW
- Southern boundary: McDaniel Street, SW
- Eastern boundary: Whitehall and Spring Streets, SW; and

WHEREAS, time is needed for the Department of Public Works to complete a comprehensive review of any and all issues related to temporary parking lots within the defined location.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA as follows:

Section 1: A moratorium is placed on the issuance of temporary parking lots in the Castleberry Hill neighborhood, defined by the following streets, with the exception of 437 Mitchell Street, SW:

- Northern boundary: Martin Luther King, Jr. Drive, SW
- Western boundary: Northside Drive, SW
- Southern boundary: McDaniel Street, SW
- Eastern boundary: Whitehall and Spring Streets, SW.

Section 2: The moratorium shall be for a period not to exceed 180 days.

Section 3: The Department of Public Works in concert with the Councilmembers from Districts 2, 3, 4 and Post 1 At-Large and representatives of the Castleberry Hill neighborhood and community


associations shall review and recommend guidelines for and/or revisions to the process, issuance and enforcement of temporary parking permits within the area as defined in Section 1 of this ordinance.

Section 4: All laws, ordinances and code provisions in conflict herewith are hereby waived to the extent of any such conflict.
