**A RESOLUTION
BY TRANSPORTATION COMMITTEE**

A RESOLUTION AUTHORIZING THE MAYOR TO AWARD AND EXECUTE A SERVICES AGREEMENT WITH MTI LIMO AND SHUTTLE SERVICES, INC. FOR PROJECT FC-6389: GROUND TRANSPORTATION SHARED RIDE SHUTTLE SERVICES AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) owns and operates Hartsfield-Jackson Atlanta International Airport (“Airport”); and

WHEREAS, the City issued Invitation to Bid for Project FC-6389: Ground Transportation Shared Ride Shuttle Services at the Airport and thereby solicited bids from pre-qualified bidders to provide shared ride shuttle services between the Airport and certain areas defined as the Central Business District of Atlanta; and

WHEREAS, a total of three (3) bids were received; and

WHEREAS, the bids were reviewed by the Department of Procurement and the Aviation General Manager and the Chief Procurement Officer have recommended that the Services Agreement for Project FC-6389: Ground Transportation Shared Ride Shuttle Services at the Airport be awarded to MTI Limo and Shuttle Services, Inc. as the most responsive and responsible bidder; and

WHEREAS, the Services Agreement will have an initial term of four (4) years, with two (2) one year options to renew the term of the Services Agreement, each of which may be exercised in the City’s sole discretion.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor is authorized on behalf of the City of Atlanta to award and execute a Services Agreement for Project FC-6389: Ground Transportation Shared Ride Shuttle Services (“Agreement”) at Hartsfield-Jackson Atlanta International Airport with MTI Limo and Shuttle Services, Inc.

BE IT FURTHER RESOLVED, that the Agreement shall have an initial term of four (4) years, with two (2) one year options to renew the term of the Agreement, each of which may be exercised in the City’s sole discretion.

BE IT FURTHER RESOLVED, that the City Attorney is hereby directed to prepare an appropriate Agreement for execution by the Mayor, to be approved by the City Attorney as to form.

BE IT FINALLY RESOLVED, that the Agreement shall not become binding upon the City and the City will incur no obligation or liability under it until it has been executed by the Mayor, or his designee, attested to by the Municipal Clerk, approved by the City Attorney as to form and delivered to MTI Limo and Shuttle Services, Inc.
