WHEREAS, the 2001 Precincts and Polling Places Ordinance, dated October 24, 2001, was adopted November 5, 2001, and;

WHEREAS, such Precincts and Polling Places Ordinance has previously been amended by action of the City Council on May 20 2002, July 15 2002, September 3 2002, October 21 2002, November 18 2002, September 15 2003, October 20 2003, April 19 2004, July 19 2004, November 01 2004, September 06 2005, November 07 2005, June 05 2006, July 05 2006, September 05 2006, October 02 2006, December 04 2006, February 05 2007, March 19 2007, May 21 2007, September 04 2007, January 22 2008, July 07 2008, November 03 2008, May 04 2009, June 01 2009, August 17 2009, October 19 2009, May 03 2010, November 01 2010, August 15 2011, October 17 2011, March 05 2012, July 16 2012, September 04 2012 and;

WHEREAS, the Fulton County Board of Registration and Elections has approved changes to City of Atlanta Precincts/Polling Places 01R, 06M, 08L, 09M and 11B as a result of a temporary relocation due to scheduled renovations of the existing facilities and address changes to polling place facilities; and also, Precincts/Polling Places 02A, 04F, 02B, 05D, 02C, 05F, 02D, 05J, 02J, 04I, 02S, 05k, 02W, 03F, 02X, 03I, 03A, 04C, 03R, 09I, 03U, 04J, 04E, 12K, 04H2, 12N, 05B, 01H, 05C, 01I, 06A, 02I, 06G, 02H, 06K, 02K, 07E, 06I, 07K1, 06N, 07K2, 06Q, 08P, 09H, 11A1, 10B, 11A2, 10I, 11G, 12I, 11H, 10K due to the 2013 Reapportionment Plan for City of Atlanta Council Districts and Atlanta Public School Districts, and;

WHEREAS, all affected voters will be notified of these changes by the Fulton County Office of Registration and Elections accordingly, and;

WHEREAS, the governing authority of the City of Atlanta, the Atlanta City Council, believes that ratification of these changes should be made by this Body.

NOW THEREFORE BE IT ORDAINED that the Atlanta City Council does hereby ratify the previous authorization and approval by the Fulton County Board of Registration and Elections of polling place changes in Precincts **01R, 06M, 08L, 09M, 11B, 02A, 04F, 02B, 05D, 02C, 05F, 02D, 05J, 02J, 04I, 02S, 05K, 02W, 03F, 02X, 03I, 03A, 04C, 03R, 09I, 03U, 04J, 04E, 12K, 04H2, 12N, 05B, 01H, 05C, 01I, 06A, 02I, 06G, 02H, 06K, 02K, 07E, 06I, 07K1, 06N, 07K2, 06Q, 08P, 09H, 11A1, 10B, 11A2, 10I, 11G, 12I, 11H, 10K** within the City of Atlanta/Fulton County; and



BE IT FINALLY ORDAINED that the Atlanta City Council does hereby Amend the 2001 Precincts and Polling Places Ordinance, dated October 24, 2001, and Adopted November 5, 2001 which was codified as Section 66-2 of the City of Atlanta Code of Ordinances and adopted by reference, by adding the recent changes to Precincts/Polling Places **01R, 06M, 08L, 09M and 11B** as a result of a temporary relocation due to scheduled renovations of the existing facilities and address changes to polling place facilities; also Precincts/Polling Places **02A, 04F, 02B, 05D, 02C, 05F, 02D, 05J, 02J, 04I, 02S, 05k, 02W, 03F, 02X, 03I, 03A, 04C, 03R, 09I, 03U, 04J, 04E, 12K, 04H2, 12N, 05B, 01H, 05C, 01I, 06A, 02I, 06G, 02H, 06K, 02K, 07E, 06I, 07K1, 06N, 07K2, 06Q, 08P, 09H, 11A1, 10B, 11A2, 10I, 11G, 12I, 11H and 10K** due to the 2013 Reapportionment Plan for City of Atlanta Council Districts and Atlanta Public School Districts, all of which are reflected or incorporated in the July 01, 2013 Revision to the 2001 Precincts and Polling Places Ordinance, identified as Attachment I to this ordinance, with certain particular changes described by the further attachment identified as **Exhibits A, B, C, D and E and the 2013 Reapportionment for the City of Atlanta Council Districts & Atlanta Public School Districts document** all being made a part hereof and noted as follows:

SECTION 1. To amend **Precinct/Polling Place 01R located at Thomasville Recreation Center, 1150 Henry Thomas Drive, SE** by changing to the correct address of **Thomasville Recreation Center, 1835 Henry Thomas Drive, SE**. The facility is located (0.3) miles from the existing facility and is accessible to the disabled as identified in Exhibit A (page 1). The polling place change of address is indicated in Attachment I (page 2). Voters will be notified of this change by first-class mail.

SECTION 2. To amend **Precinct/Polling Place 06M located at Mary Lin Elementary School, 586 Candler Park Drive, NE** by temporarily moving said precinct to **Epworth United Methodist Church, 1561 McLendon Avenue, NE** and combining with Precincts 05P and 06P due to renovations of the existing facility. The proposed facility is located approximately (0.5) miles from the existing facility and is accessible to the disabled as identified in Exhibit B (pages 1-3). The new polling place is indicated in Attachment I (page 13). Voters will be notified of their voting location change by first-class mail.

SECTION 3. To amend **Precinct/Polling Place 08L located at E. Rivers School, 8 Peachtree Battle Avenue, NW** by temporarily moving said precinct to **Cathedral of Saint Phillip, 2744 Peachtree Road, NW** and combining with Precinct 07F due to renovations of the existing facility. The proposed facility is located approximately (0.9) miles from the existing facility and is accessible to the disabled as identified in Exhibit C (pages 1-3). The new polling place is indicated in Attachment I (page 17). Voters will be notified of their voting location change by first-class mail.

SECTION 4. To amend **Precinct/Polling Place 09M located at Fire Station #28, 2040 Main Street, NW** by changing the address to the new location of said precinct to **Fire Station #28, 1925 Hollywood Road, NW**. The proposed facility is located approximately (0.3) miles from the existing facility and is accessible to the disabled as identified in Exhibit D (pages 1-3). The new polling place is indicated in Attachment I (page 19). Voters will be notified of their voting location change by first-class mail.

SECTION 5. To amend **Precinct/Polling Place 11B located at Ralph Bunche Middle School, 1925 Niskey Lake Road, SW** by temporarily moving said precinct to **Fickett Elementary School, 3935 Rux Road, SW** and combining with Precinct 11C due to scheduled renovations of the existing facility. The proposed facility is located approximately (1.7) miles from the existing facility and is accessible to the disabled as identified in Exhibit E (pages 1-3). The new polling



place is indicated in Attachment I (page 22). Voters will be notified of their voting location change by first-class mail.

SECTION 6. To amend **Precinct/Polling Place 02A located at Centennial Elementary School, 531 Luckie Street, NW**, to re-designate Precinct 02A to **Precinct 04F located at Centennial Elementary School, 531 Luckie Street, NW** due to redistricting and further amend to delete Precinct 02A. The proposed facility is referenced in the 2013 Reapportionment Plan for the City of Atlanta & Atlanta Public School Districts document (pages 1-3). The new polling place is indicated in Attachment I (pages 4 & 10). Voters will be notified of their voting location change by first-class mail.

SECTION 7. To amend **Precinct/Polling Place 02B located at Saint Luke's Episcopal Church, 435 Peachtree Street NE**, be moved to and split with **Precinct 05D, located at Saint Luke's Episcopal Church, 435 Peachtree Street, NE** due to redistricting. The proposed facility is referenced in the 2013 Reapportionment Plan for the City of Atlanta & Atlanta Public School Districts document (pages 4-6). The new polling place is indicated in Attachment I (pages 4 & 13). Voters will be notified of their voting location change by first-class mail.


SECTION 8. To amend **Precinct/Polling Place 02C located at Cosby Spears High Rise, 355 North Avenue, NE**, be moved and split with **Precinct 05F, located at Cosby Spears High Rise, 355 North Avenue, NE** due to redistricting. The proposed facility is referenced in the 2013 Reapportionment Plan for the City of Atlanta & Atlanta Public School Districts document (pages 7-9). The new polling place is indicated in Attachment I (pages 4 & 14). Voters will be notified of their voting location change by first-class mail.
