AN ORDINANCE BY COUNCILMEMBER(S) JOYCE SHEPERD, CLETA WINSLOW, YOLANDA ADREAN, MICHAEL J. BOND, HOWARD SHOOK, H. LAMAR WILLIS, CARLA SMITH, NATALYN M. ARCHIBONG, KEISHA LANCE BOTTOMS, C. T. MARTIN, HOWARD SHOOK, ALEX WAN, KWANZA HALL AND IVORY L. YOUNG, JR. AS AMENDED BY COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE TO AMEND SECTION 2-200 OF THE CITY OF ATLANTA CODE OF ORDINANCES, ENTITLED "FUNCTIONS AND DUTIES OF THE CITY OF ATLANTA OFFICE OF ENTERTAINMENT" TO REQUIRE THAT THE OFFICE OF ENTERTAINMENT APPEAR BEFORE THE FINANCE/EXECUTIVE AT LEAST THREE TIMES PER YEAR TO REPORT ON ITS STRUCTURAL PROCESSES; THAT THE OFFICE OF ENTERTAINMENT SHOULD APPEAR BEFORE THE COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE AT LEAST THREE TIMES A YEAR TO REPORT ON ITS ECONOMIC DEVELOPMENT ACTIVITIES; AND FOR OTHER PURPOSES.

WHEREAS, Ordinance 13-O-0641 seeks to the City of Atlanta ("City") Code of Ordinances to establish the Office of Entertainment ("Office") in the Department of the Mayor; and

WHEREAS, the Office should appear before the Committee of Purview at least three times a year to report on its activities; and

WHEREAS, the Office should appear before the Community Development/Human Resources Committee on economic development activities; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: The Atlanta Code of Ordinances, Part II, Chapter 2 (Administration), Article IV (Executive Branch Offices), shall be amended by adding Subsection 8, which shall now read:

- (8) To report to the Finance/Executive Committee at least three times per year on its structural activities.
- (9) To report to the Community Development/Human Resources Committee at least three times per year on its economic development activities.

SECTION 2: All ordinances in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of said conflict.
