**An Ordinance to amend the City of Atlanta Code of Ordinances Section 66-2 "Precinct Boundary Lines and Polling Places" by Adopting a new list of "City of Atlanta Precincts and Polling Places (as of August 19, 2013)" and a new "City of Atlanta Council Districts and Voting Precincts Map" Dated August 19, 2013", and for other purposes.**

**WHEREAS**, the 2001 Precinct and Polling Place Ordinance adopted by Council November 5, 2001 and approved by the Mayor November 13, 2001 has been amended numerous times due to a myriad of reasons including but not limited to construction at existing facilities and resulting relocations, the combining of precincts, annexations, census changes and redistricting; and

**WHEREAS**, because of these numerous changes it has become necessary to establish a new list of Fulton County and DeKalb County precincts and polling places within the City of Atlanta; in both Fulton County and DeKalb County; and

**WHEREAS**, it has become equally necessary to prepare a revised map of the City of Atlanta that denotes current Council districts and boundary lines as well as precinct designations and boundary lines.

**NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:**

**Section 1:** That Section 66-2 of the City of Atlanta Code of Ordinances be deleted in its entirety and replaced with a new Section 66-2 to read as follows:

**Section 66-2 Precinct Boundary Lines and Polling Places.**

The precincts, polling places and maps showing precinct boundary lines within the City of Atlanta shall be designated, changed or created in accordance with O.C.G.A. 21-2-260 to 21-2-270.

The precincts and polling places within the City of Atlanta in both Fulton and DeKalb Counties are specifically described in a document titled "City of Atlanta Precincts and Polling Places, (as of August 19, 2013)" The city-wide Council districts boundary lines with corresponding precinct designations and boundary lines are specifically shown on a map titled "City of Atlanta Council Districts and Voting Precincts Map", dated August 19, 2013. Both are on file in the Office of the Municipal Clerk, and are incorporated in this chapter and adopted by reference as the official "City of Atlanta Precincts and Polling Places", and the official "City of Atlanta Council Districts and Voting Precincts Map."

**Section 2:** That the document titled "City of Atlanta Precincts and Polling Places (as of August 19, 2013)" is attached to this ordinance and identified as Exhibit A.



**Section 3:** That the document titled "City of Atlanta Council Districts and Voting Precincts Map" is attached to this ordinance and identified as Exhibit B.

**Section 4:** That all ordinances or parts of ordinances that are in conflict with the terms of this ordinance are hereby repealed.
