**A RESOLUTION AUTHORIZING THE MAYOR ON BEHALF OF THE CITY OF ATLANTA TO ACCEPT THE DONATION OF BALL FIELD IMPROVEMENTS VALUED AT APPROXIMATELY TEN THOUSAND DOLLARS AND NO CENTS (\$10,000.00) AND ALLOWING A SMALL RECOGNITION SIGN FROM THE ATLANTA BRAVES FOUNDATION AND THE CHIPPER JONES FAMILY FOUNDATION FOR USE AT THE WEST MANOR PARK BALLFIELD; AND FOR OTHER PURPOSES.**

**WHEREAS**, the Department of Parks, Recreation and Cultural Affairs (“DPRCA”) provides a number of amenities and recreational programs to Atlanta residents on behalf of the City of Atlanta (“City”); and

**WHEREAS**, the Atlanta Braves Foundation is the non-profit arm of the Atlanta Braves Baseball Team that actively supports community organizations and programs within the metro Atlanta area and each year, the Atlanta Braves Foundation grants funds to youth-serving organizations that focus on health, education, and recreation; and

**WHEREAS**, the Chipper Jones Family Foundation is a nonprofit organization dedicated to youth baseball and has instituted the Around the Horn Program Field of Dreams Program, which has given hundreds of thousands of dollars to area youth baseball programs for repairing and refurbishing youth ballparks in Florida and Georgia; and

**WHEREAS**, the City’s West Manor Park has been selected as one of the stand alone parks to receive a donation in the amount of Ten Thousand Dollars and No Cents (\$10,000.00) for the purpose of ball field improvements; and

**WHEREAS**, the City will benefit from this donation and is appreciative of the generosity of the Atlanta Braves Foundation and the Chipper Jones Family Foundation.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the Mayor, on behalf of the City, is authorized to accept the donation of ball field improvements valued at approximately Ten Thousand Dollars and No Cents (\$10,000.00) from the Atlanta Braves Foundation and the Chipper Jones Family Foundation.

**BE IT FURTHER RESOLVED**, that a small sign may be placed in West Manor Park in recognition of the Atlanta Braves Foundation and the Chipper Jones Family Foundation.



**BE IT FINALLY RESOLVED**, that to the extent that the Atlanta Braves Foundation and the Chipper Jones Family Foundation is donating time and resources to the City, the City hereby accepts the donation.
